1. Technically the **NW-SE and SW-SE do not exist**, this is **Government Lot 5**, please change all references to the said ¼- ¼ to Government Lot 5
2. The exterior of all lands being divided need to be shown as a **solid line**
3. Please show the roads as **dedicated to the public** and please add the **Square feet of the area** of the right of way being dedicated
4. Per our phone conversation please change the **fence symbol to match the legend**
5. In looking at the remainder of the **property to the north of proposed Lot 1**, is this area over 35 Acres? **Does this need to be included on the CSM as another Lot or another CSM?**
6. Please **trim** the section line and marco drive lines that are outside of the boarder
7. In the notary block above the city of la crosse approval there are 2 spelling errors
  - a. **Secretart** should be **Secretary**
  - b. By **it** authority should be **it's**
