

STREET PRIVILEGE PERMIT # 418

Pursuant to Sec. 66.045, Wis. Stats., La Crosse Footwear, Inc., Box 1328, La Crosse, Wisconsin, is hereby granted a street privilege permit for curb cut in street right-of-way of St. Andrew Street in accordance with the attached letter and drawing. In granting this permit, the applicant agrees to comply with the following terms and conditions, which agreement shall be indicated by the affixing of the signature of said applicant:

1. The applicant shall be primarily liable for damages to person or property by reason of the granting of this street privilege permit.

2. Applicant waives any and all rights to contest in any way or manner the validity of Sec. 66.045 of the Wisconsin Statutes.

3. Provision for a bond is hereby waived.

4. Applicant agrees to furnish the Board of Public Works satisfactory written evidence that it has in force and will maintain during the life of the permit, public liability insurance in amounts not less than \$100,000 each person, \$300,000 each accident for bodily injury and for property damage \$100,000.

5. Applicant agrees that if it does not remove the curb cut within ten (10) days after receiving notice from the City to do so, the City is authorized to remove the same and applicant agrees to pay the City for all costs of such removal.

6. Applicant further agrees that the City shall not be liable to applicant for any damage applicant may receive by reason of the curb cut or should the same be damaged by the City if the City performs work or maintenance in the area of the street privilege permit.

7. Applicant further agrees that the obligations and conditions of this street privilege permit shall be binding upon all heirs, successors and assigns of applicant.

I have been informed by our contractor that the curb cut requested by LaCrosse Footwear, Inc. requires a letter from us in order to proceed.

We are requesting this cut to simplify the entrance into our plant in order to prevent accidents. We have numerous deliveries at this entrance and the elimination of the curb will allow dolly truck deliveries without lifting over the curb. This area is also the only entrance for factory personnel and would reduce the tripping hazard. We frequently use this area for contractor entry and a ramp to the front door provides better access.

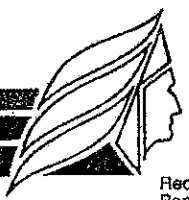

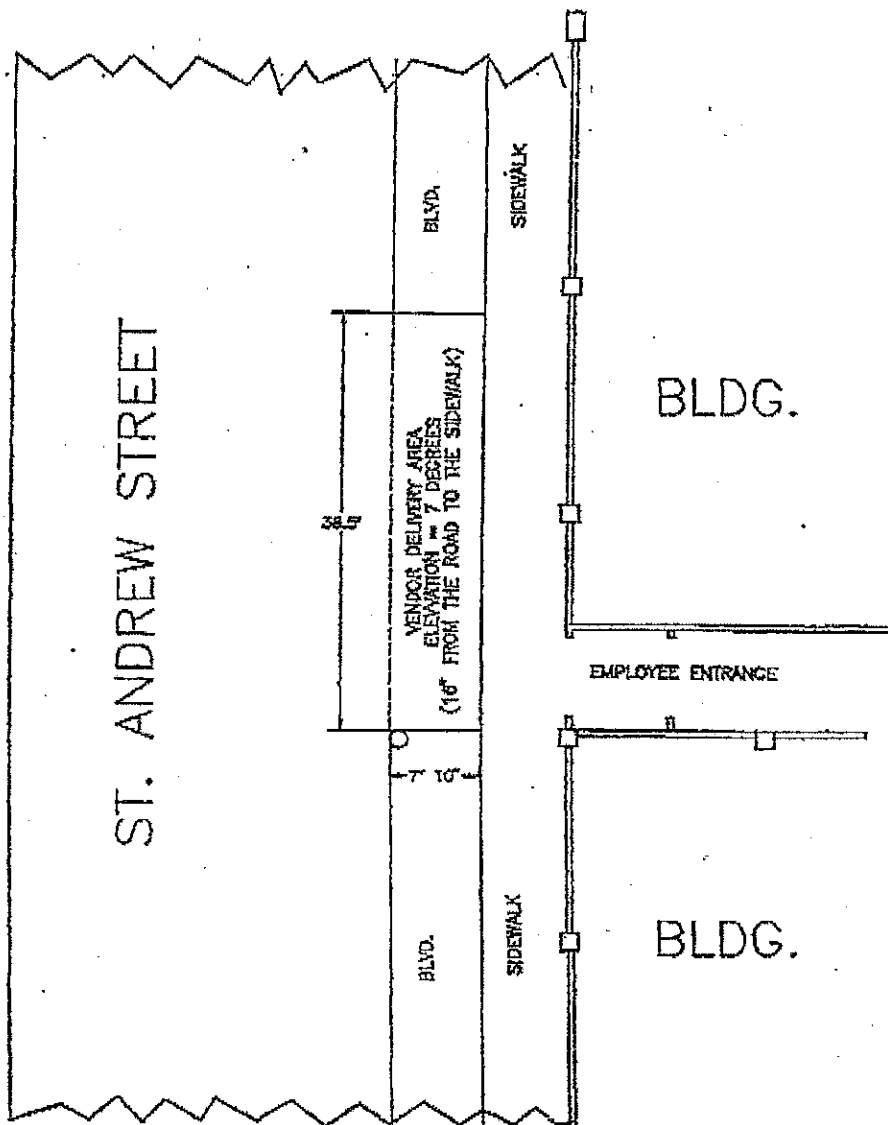
