 AN ORDINANCE to amend Sec. 10-623(b)(6) and Sec. 10-624(d) of the Code of Ordinances of the City of La Crosse regarding public vehicle for hire titles.
 THE COMMON COUNCIL of the City of La Crosse do ordain as follows:
SECTION I: Section 10-623(b)(6) is hereby amended to read as follows:
 Sec. 10-623. - Application.
 (b) The application shall contain the following information:
 (6) A description of each vehicle by factory number, year, make, and model; as well as provide a photocopy of the title (or application for title transfer Confirmation of Ownership) and registration for each vehicle which shall be in the name of the business/owner;
SECTION II: Section 10-624(d) is hereby amended to read as follows:
 Sec. 10-624. - Fee and miscellaneous restrictions.
 (d) Any vehicle which has ever been issued the title class of "salvage," "rebuilt," "junk," "total loss" or an equivalent classification is not eligible for operation as a vehicle for hire unless repaired and inspected by an authorized salvage vehicle inspector and rebranded for road use.
SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.
SECTION IV: This ordinance shall take effect and be in force from and after its passage and publication.
