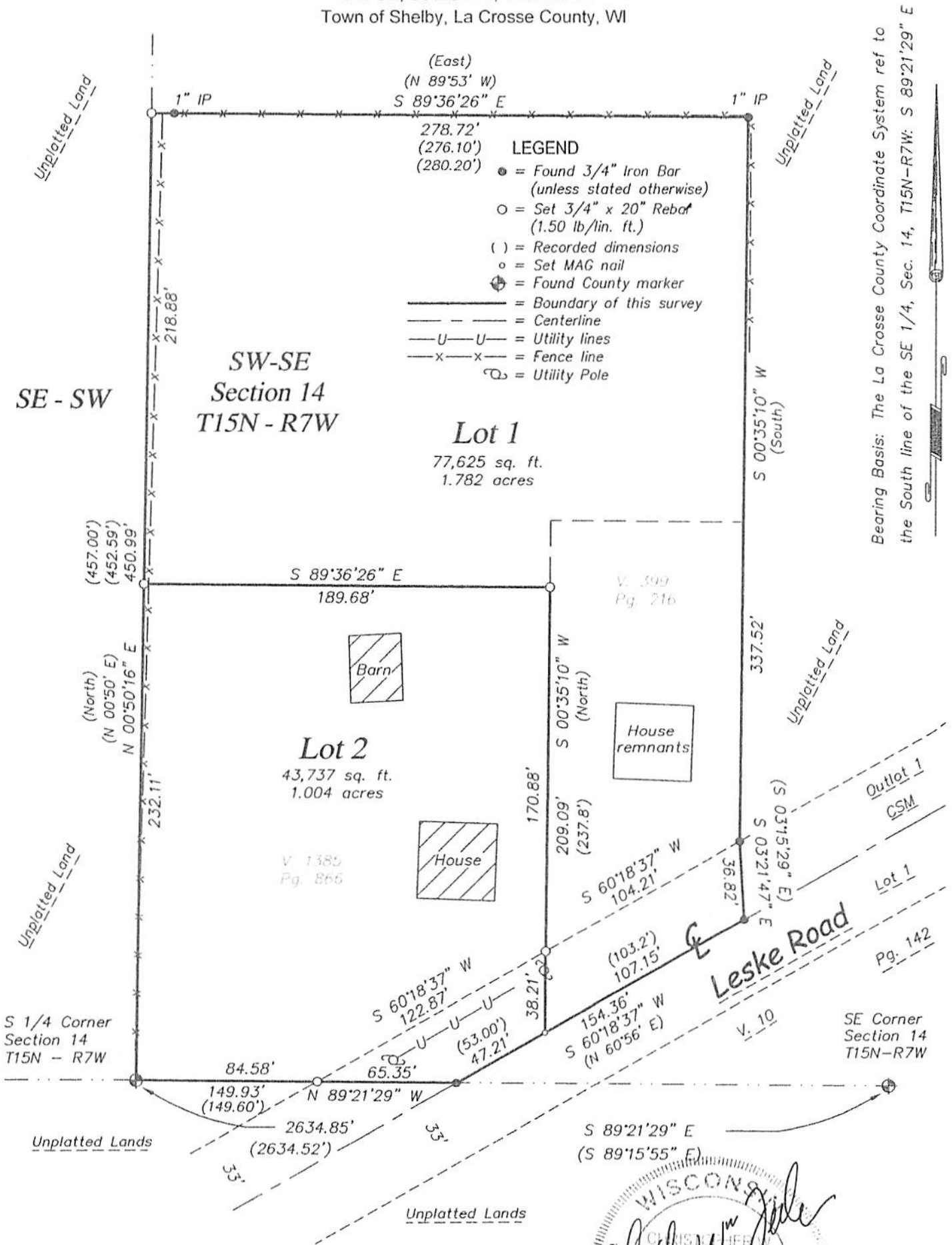


CERTIFIED SURVEY MAP

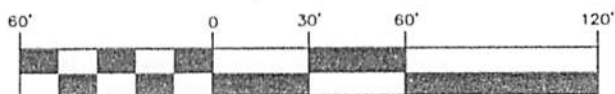
SW-SE, Section 14, T15N-R7W


Beginning at the South 1/4 corner of Section 14, thence, along the West line of the SE 1/4, N 00°50'16" E 450.99 feet;
thence S 89s36'26" E 278.72 feet;
thence S 00°35'10" W 337.52 feet to the northerly right-of-way line of Leske Road;
thence S 03°21'47" E 36.82 feet to the centerline of said Leske Road;
thence, along said centerline, S 60°18'37" W 154.36 feet to the South line of said SE 1/4;
thence N 89°21'29" W 149.93 feet to the point of beginning of this description.

Subject to any easements, covenants and restrictions of record.
