

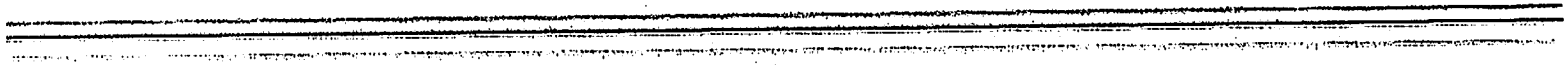
**RESOLUTION**

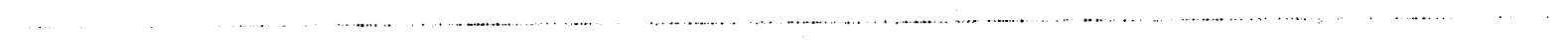

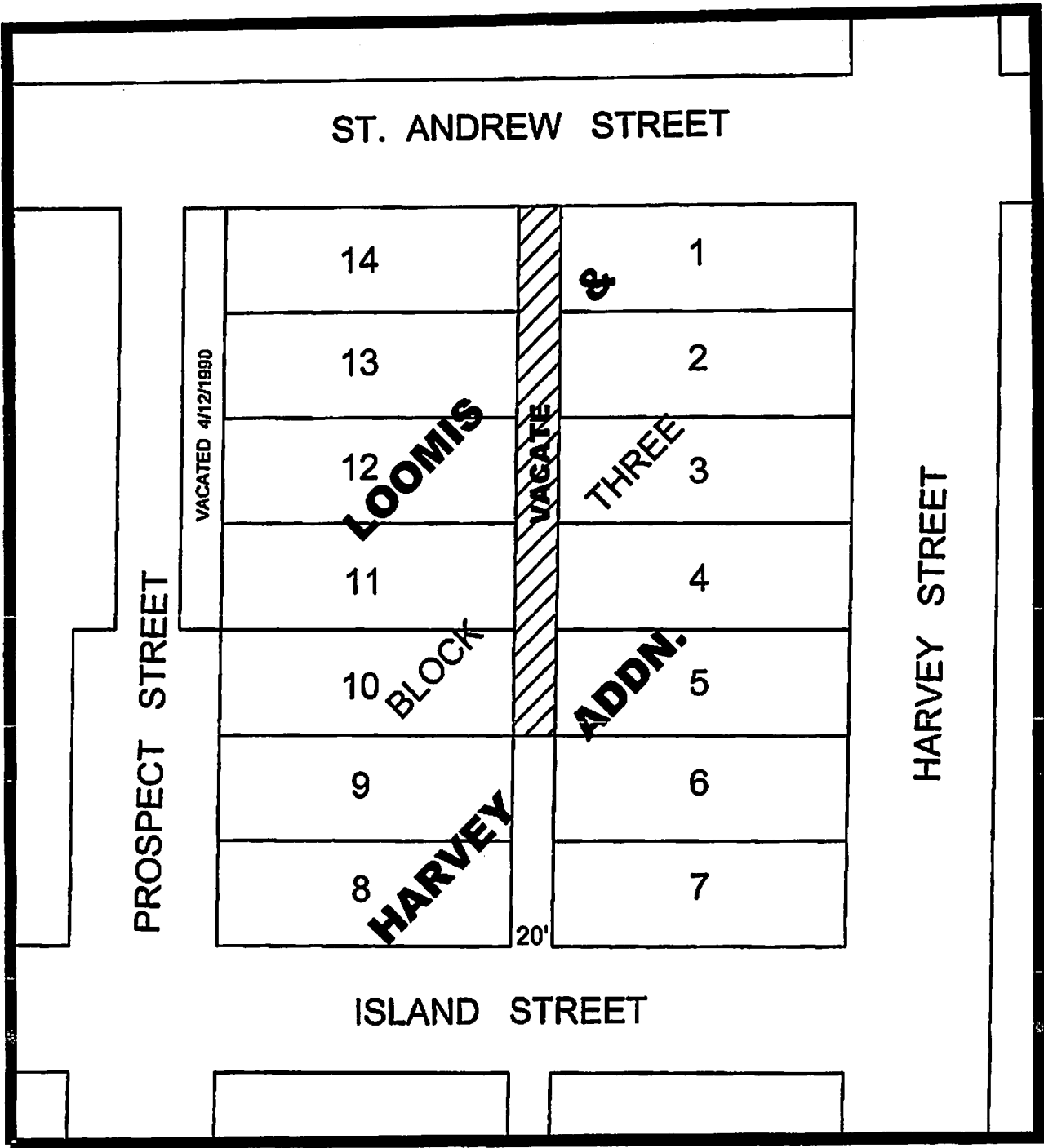
