RESOLUTION


WHEREAS, the City of La Crosse and the Town of Shelby seek to prepare a Cooperative Plan under Wis. Stats. § 66.0307; and

WHEREAS, by this Resolution, the City of La Crosse City Council is committed to the establishment of an agreement with the Town of Shelby that will help determine where and how new development will occur in areas currently within the Town, improving predictability for all parties and enabling sustainable development and growth;

NOW, THEREFORE, BE IT RESOLVED by the La Crosse City Council, that:

1. The La Crosse City Council, officers, staff and consultants are authorized to participate in the preparation of a Cooperative Plan under the procedures and standards set forth in Wis. Stats. § 66.0307;
2. Notice of the adoption of this Resolution and that of the Town of Shelby shall be given by the City Clerk, in writing, within five days of the adoption of this Resolution to:
 - (a) The State Department of Administration, the State Department of Natural Resources, the State Department of Agriculture, Trade and Consumer Protection and the State Department of Transportation;
 - (b) The Clerks of every municipality, School District, Technical College District, Sewerage District or Sanitary District which has any parts of its territory within five miles of the boundaries of either participating municipality;
 - (c) The La Crosse County Clerk; and
 - (d) The La Crosse Area Planning Committee and the La Crosse County Department of Planning and Development.
