# INCIDENT REPORTS FROM SOME OF THE RESIDENTS OF THE LANDINGS 14 COPELAND AVENUE LA CROSSE

#### 4/11/2024

On Thursday afternoon, April 11th, around 2:45pm I became aware of a man staggering around on the bike trail below my balcony at The Landings Condos who was clearly impaired and laughing and talking loudly (to himself I believe). I watched (and recorded) from my balcony. He was shirtless, Asian, maybe 30-40-ish, slim build, wearing drooping black pants with white undies folded over the top. He was scraping at the bark of a small tree by the La Crosse River below my balcony with what appeared to be a stick or pole about 24" long as he carried on in a rant. He was making gouges in the bark of the tree with the stick (which are still visible). He walked up the sidewalk toward our building at the back under my balcony and attempted to enter the door as he laughed and ranted "they locked the door". He picked up a couple of fist sized rocks from the landscaping and wandered back to the trail. An attempted break-in?

He walked north toward Festival Foods on the path and sat on the river bank for a bit, put his shirt on and hung a black and blue backpack in the tree by the deck/bench on the river on the north side of the building by our north parking lot. At this point I called 911 and they said they would send an officer to investigate. The man then took something out of the backpack leaving it hanging in the tree and removed his black shirt and stuck it under one of the big boulders along the trail, and continued to pace back and forth along the path. (The backpack would remain hanging there into the evening.)

As the man came closer, I could see that he was wielding nunchucks (apparently they had been stuck together and that's what I thought was a pole). He walked back and forth several times posing and swinging the nunchucks, passing along the bike path, still shirtless, and then I guess he realized he had left his shirt under the rock and came back to collect it. He put it on and continued southwest along the bike path where he disappeared around our building in the direction of Riverside park. I continued watching to see if he would come back for the backpack, but he did not under my watch. I called the police back at about 3:30 pm that afternoon as I had not seen an officer, and was told that an officer had come to investigate and walked the bike path but could find no one. Not sure what time that happened because I didn't see anyone in uniform on the bike path or anyone else for that matter. I told the dispatcher that I had videos and photos on my phone, but

heard no follow-up. I suspect that the officers went to the wrong part of the trail or came by after the man had long disappeared.

## 4/21/2024

Fire in marsh. Called 911 to report fire. Nancy and Jerry Rank (#214)

## 4/22/2024

Walked the Veteran's Trail and was asked by homeless guy for money. Mary Kay Kayanaugh (#215)

## 4/22/2024

9:30 AM Walking toward The Landings from Copeland Ave on the sidewalk behind Borton Construction/Wipfli building. Saw a policeman by the edge of the river, holding something - a gun he had been told about in the bank, by a woman walking her dogs. Identified it as a BB gun but it looked like a "real" gun. It was still clean. Officer removed it.

3:30 PM Delivered needles to Fire House #2. I found them when I was cleaning up trash on the Jim Asfoor Trail, and a Festival bag I picked up fell apart and scattered needles. I informed the fireman who accepted them about another site, next to the trail, which I also found littered with needles. He said they would pick them up.

4/29/2024

6:20 AM I was solicited for a sexual act when walking on the Veterans Trail, about 250 yards in from Lang Drive. The man was a white male, late 30s to early 40s, unshaven, wearing a camo jacket, watch cap and dark pants. Dave Lupes (#305)

5/1/2024

5:30 AM Yelling and screaming/vulgar language (from camp across river). Finally at 5:50AM I called city police. I talked to officer later and he said it was a domestic. No arrests.

6:55 PM. Called 911. Campfire in marsh. Kathy Zieja (#311)

5/3/2024

1:15 PM My daughter and I walked the Vietnam Veterans Trail from Lang Drive to Copeland Avenue. We saw trash strewn right next to the trail and down into the marsh, and when we reached the area behind the River Architects building, a group of seven people, mostly men, was gathered around the picnic table. As we passed them, making sure not to make eye contact, two of the men turned to us and screamed out. We don't know if they were on drugs, mentally ill, or just trying to scare us. They glared at us, but didn't get in our way. Once again, we have decided not to walk on that trail. - Neva Von Haden (#203)

5/3/2024

9:30-9:50 PM Screaming in the marsh. Neva Von Haden (#203)

5/3/2024 (?)

Called 911. Fire across river from the Borton/Wipfli building. Nancy Rank (#314)

5/5/2024

11:15 I called the non-emergency police number to report a verbal altercation across the river, likely involving the green tent across from our unit, although with the leaf out conditions, I can't be sure about that. Police responded very quickly, asking for location clarification. The shouting, with the usual F\*\*\* You language, included a woman's scream and someone shouting, "Don't push me!" I decided it was getting physical enough to warrant the call.

Spoke with DNR about boat on river (behind The Landings) at midnight, with no running lights. Same boat is here often, at various times, day and night. Also regularly at midnight, 2:00AM, and 4:00AM. Provided pictures of the boat taken earlier in day, as well as location where the boat is stored on the Black River. Kathy and Tom Zieja (#311)

I have also seen (and HEARD) the boat Kathy and Tom Zieja mentioned in the previous entry. Only LATE at night. No running lights. Coming and going, repeatedly.

2:40 PM Police observed pulling into Wipfli parking lot. They went to bike trail for approximately 2 minutes, then sat in squad car for 5 minutes and exited behind Festival.

## 5/15/2024

I exited the single door on the north end of our building at about 7:10PM (still light out), to go to Festival. JUST outside the door, RIGHT in front of me, was a seedy-looking man, standing, straddled, over a red small-wheeled bike. I darted quickly past and to the corner, glancing over my shoulder, keeping track of where he was. He moved, with his bike, to just behind our building's chillers, on the river side. I watched him take something out of his pocket and look at it. I crossed over and stood to watch in front of Festival. A big guy pulled a van into an Altra parking space and got out. The guy on his bike rode over and dropped his bike on the grass in front of the big guy's van, and the two guys crossed over the Landing's grassy area next to our chillers, toward the river. Less than a minute later, they came back and went their separate ways. This appeared to be a drug deal. Those are increasing, in the marsh behind us, on surrounding trails, and around The

Landings. The screaming and fighting across from us, day and night, is also increasing. Neva Von Haden (#203)

#### 5/16/2024

12:21 PM Called 911 about a disturbance across the river. Dispatch was able to hear the disturbance in the background (on the phone). Yelling and profanities. Male and female voices. No known response from law enforcement. Kathy Zieja (#311)

## 5/16/2024

3:05 PM. Called 911 again about domestic disturbance directly across river from our rain garden. Male and female arguing, yelling, profanities. Female referred to male as "putting hands on me" and "pulling hair". No known response from law enforcement.

#### 5/17/2024

Spoke with an officer who was on patrol. Discussed our situation, as well as the late-night boat with no running lights. She said we should continue to call. She also provided the names of Lt. Smith or Sgt. Oates, who can be contacted through non-emergency 608-782-7575. She also said someone was arrested regarding shooting a gun in the marsh. Additionally, she said the police are regularly patrolling the bike trail and walk in from the architectural building.

## 5/17/2024

Dear Mayor Reynolds and members of the Public Works Committee:

We are writing regarding your June decision about whether or not to ban camping in the marshland along the Veterans' Trail between Copeland Avenue and the pedestrian bridge. We urge you to actually visit the encampment before you make a decision.

We wrote before your April meeting and had two concerns: fire and garbage. We also attended that meeting. Our first concern has been allayed as the fire department has responded numerous times to reports of open fires. Chuck Lee of "Friends of the Marsh" assured us after the April meeting that fires are, in fact, good for the ecology of the marsh. Of course, this leaves the possibility of a tragic human toll if a fire rages out of control in the hot summer days to come.

The issue of garbage remains. Chuck assured us that the Friends of the Marsh attends to this, but we walked the Veterans-Asfor trail this past Wednesday after time away. The garbage situation seems to be worse, even though the Friends of the Marsh advertised a clean-up. A greater concern now is the raw sewage that is being dumped into the river. We would ask you on your visit to assess how human excrement is actually being handled and what the consequences may be to both human and ecological health. Chuck assured us that city workers are visiting the encampments twice a week, so they could presumably add more data to your own onsite assessment.

After the April meeting, we felt that the city had the situation in hand and that patience was warranted. We have no expertise but felt that this small area could handle the six encampments we had counted. We no longer believe this. Since no regulation seems possible, this situation will not remain stable and can only worsen. At the end of April, we counted 19 camp sites. It is now hard to count because of the greenery, but rumors abound of new carloads of people, with tents, being dropped off into this small area. Again, your own count is needed.

Meanwhile there are definite signs that the city may now be sponsoring a haven for drug users.

- On our May 15 evening walk we saw a jolly man on a bicycle pulling a cart. He met a young man who popped out from the north encampment for some kind of an "exchange". Our neighbors are witnessing a growing number of such incidents. They are happening close to our home, and the people involved are increasingly bold and menacing. Calls to the police are ineffective since the individuals are long gone before anyone arrives. With the city's present reactive stance, it seems it will take a tragic assault to prompt action.
- A boat with a flashlight prowls the water in the midnight hours.
- The number of loud arguments and screams from the encampment, day and night, is definitely increasing.
- On a pleasant spring night, we used to see families and bikers and couples using the trail. On this last walk it was early empty except for our jolly biker.
- Gunshots have been reported several times.

These cumulative observations point to a situation that is no longer adequately described by the word "homeless." We believe that the city's inaction is effectively sponsoring an environment of growing violence and drug use and, with this, an increasing probability of victimization. It is not hard to imagine what summer heat will bring in terms of human misery.

What to do? Waiting five years for "Pathways Home" to be in place is not an answer. Environmental degradation will continue in this unregulated patch of land as the population increases and tragedy (assault or, God forbid, death) is highly likely. We realize that there is no single answer but we get impatient when inaction is excused by saying that Houska Park or the Econo Lodge did not work. Every attempt to address this complex situation will need to build on failures as well as successes: why didn't those situations work? Could they be reimagined in another try? We personally believe that the answer does not lie in herding two hundred plus people into one place: confining the most vulnerable population with predators is just not a good idea. Regarding the campers across the way, perhaps the twenty households could be offered city-

funded camping facilities in four campgrounds around the county where humane living conditions would be possible. The yellow van could bring needed supplies to those sites. If campers reject such an offer, we don't understand why our precious public spaces should be sacrificed for the benefit of people whose personal preferences for rough camping are destructive to the environment and to community safety and well-being.

Please don't callously dismiss our concerns about the degradation of our neighborhood. Conditions are worsening in observable ways. Prohibiting camping in the marsh on June 3 will press solutions regarding campers that can be addressed thoughtfully now rather than in the middle of a tragedy.

We do thank you for all of your work on behalf of us all. Public service is a difficult challenge in these times and we appreciate the time and effort you invest in making La Crosse a good place to live for all of us.

Re: Camping in the Floodway

The City of La Crosse is allowing camping in the floodway in the lands between the Asfoor and Veterans Trails from the Copeland Bridge to Monitor. According to the Floodplain Zoning Map, those lands, some city-owned and some privately owned, are in the floodway. Camping is not listed as a permitted use of land in the floodway for good reason: to avoid the flooding that happens as it did a few years ago when the floodway area in question was a lake.

Today's NWS weather forecast cites risks of heavy rain in the days just ahead. We and others strongly urge the city to take action promptly to avoid the need to rescue campers from a severe rainstorm and flooding; one-inch per hour rains were seen as possible. Public safety officials have indicated their concern for such an event happening.

There is a further prohibition in the zoning code on uses "not in harmony with or detrimental to uses permitted in the adjoining districts." The Landings neighborhood of 44 homes is in the district that abuts the floodway. Landings residents have repeatedly objected to the camping citing multiple reasons why it is detrimental. There are further prohibitions on "habitable structures" and the presence of materials that are buoyant, flammable, explosive, injurious to property, water quality, or human, animal, plant, fish or other aquatic life.

As for the Public Works meeting scheduled in June to reconsider banning camping in some marsh properties, it may not be needed since the camping in question is already banned under the city's floodplain zoning.

Thank you for your prompt attention to this urgent matter.

Dear Mayor Reynolds and Board of Public Works,

My name is Kathy Zieja. My husband and I live at the Landings Condo's at 14 Copeland Ave., La Crosse, Wi. facing the La Crosse River. We have resided here since 2007. Our building has 44 units with 22 facing the La Crosse River. We moved to the Landings due to the beauty of the river and the surrounding marsh. We are amazed at the diversity of animals, birds and beautiful nature in close proximity to downtown La Crosse. We love the bike trail that allows our community to enjoy this great area. This has been a great place to live but there has been a significant change within the last year.

We are now experiencing daily, chronic disturbances from the homeless encampments that are inhabiting the marsh and floodway along the river and bike trail. The time frame of this change coincides with the clearing of the encampments from the Black River near Riverside Park. They have moved to the "backyard" of our homeowners. Since the change occurred, we experience disturbances daily including gun shots, screaming, hollering, and profanities. There are domestic disturbances with physical altercations among the "campers". We have called the police due to the altercations in hopes that no one will be injured. We also are concerned for our own safety. We are

awakened at all hours of the night along with hearing this throughout the day. Drug deals are being observed near the bike trail. Many needles have been found for which the fire department has been contacted. Campfires have been burning during burn bans and the fire department has been called. Our vehicle has been broken into with damage to two windows along with theft of personal belongings. A resident has been sexually propositioned while walking the trail. On a regular basis, a 14 foot Alumacraft had been traveling up and down the river several times per day. Frequently this was late at night, beginning midnight with multiple trips per night, waking us up. We have contacted the DNR as the boat has no running lights. We were advised the boat owner was arrested on an outstanding warrant.

This area is no place for the encampments with no potable water or toilet facilities. The trash piling up is significant. The environment is fragile. How is it that the encampments were evicted from the Black River area but this issue is tolerated along the La Crosse River between the Asfoor and Veterans Trails? Both areas are located in the flood plain. Many homeowners are affected as well as those who wish to enjoy the bike/walking trails.

We are aware of plans to assist the homeless with the Pathways Project and applaud anything that can be done to help them secure adequate housing. We are aware that this is anticipated to take several years. Are we to anticipate that we will need to wait years before the encampments across from our home are addressed? The encampments were not tolerated along the Black River and we hope that they will not be tolerated along the La Crosse River.

5/20 to 5/21/2024

Last night around 11:45 pm, I was awakened by a woman yelling and swearing in the marsh encampment. It was so loud, I thought at first that she was on the trail right under my bedroom window. Occasionally a man's voice interjected like maybe he was trying to calm her down. I couldn't understand many words, other than "F-bombs". Close to midnight, when I got up to get my phone, their voices trailed off, like they were walking toward the Veteran's trail, but I could still hear her. And his voice was getting louder. At 12:05 am I called 911. The dispatcher said she would send someone as soon as possible. About this time, men in other areas of the marsh started yelling, "Shut up" and 'Shut the F\*\*\* Up". She screamed back, 'No!" and more "F-bombs". Around 12:15 am, I saw flashlights in the vicinity of the big green tent with the yellow flags around it, and hear a dog bark and growl loudly. Then everything stopped. It was eerily quiet. Until sometime after 4 am, and after the loud thunder. Then it sounded like she was going to get started again, but it was muffled, and it didn't continue. Fran Rybarik (#211)

On Thursday May 16 I was out with my dog on the north side of the apartment complex (near the chillers/chain link enclosure) at 8:30-9:00PM. There was a large bonfire across the river, which appeared to be behind the tent closest to the bend in the river. I did not even think to call the fire department at the time, but was concerned to see a large bonfire in such a wooded area.

#### 5/26/2024

Fire in the marsh across from rain garden during rainfall. I did not call it in, as it was out shortly after I noticed it. The boat guy is back, making multiple trips up and down the river. He docked across from the rain garden, where the campfire was, later. He seems to have a light on the back of his boat, which is required for night travel.

7:30 AM Campers started playing loud rap music directly across the river. Jennifer and Dave Lupes (#305)

#### 5/28/2024

6:20 AM Called non-emergency number about distressed dog, loudly barking and howling, tied to the little tree on Landings property, just north of our chillers. It had gone on for at least 20 minutes. Dispatch asked what breed it was. I told him from my balcony it looked like it could be a pit bull. A woman in a red jacket finally came and took it off of the tree (she probably had been in Festival) and headed down the Jim Asfoor Trail (toward Monitor St). She then loitered about at the intersection of the trail and Festival's driveway. Officer called me to ask where the dog was. Then she said she spotted the woman. Before we hung up, I asked that she find out if the dog is licensed and vaccinated. Told her that I'm still paying off a bill for rabies treatment from an unlicensed, unvaccinated pit bull-mastiff bite I received 16 months ago.

Heard a man in the marsh, across from the south end of the rain garden and across from my porch, talking loudly, lots of profanity. I was able to understand a few phrases, "What about me? Why are you saying 'we'?" I could hear him in every part of my condo.

At first, I thought he was talking to someone else, but as time went on, he moved between the front of his green tent and the river. And began gesticulating with his arms and yelling at unseen people or things. At one point he said something about being able to see in windows that other people look out. He had long dark hair and a baggy light-colored shirt on. When he continued to rant, I noticed Mary Kay working in the rain garden on the phone. She confirmed she had called the situation in to the police. About 4:10, he quieted down a bit. I could see him kneeling in his tent. It looked like two people with something red on stopped to talk to him. Not sure if they were other marsh residents or first responders. Shortly after that, he came back between his tent and the river yelling, "maybe I should start killing again." And something about women being the worst. Then people were walking through the marsh on a trail behind his tent, and he talked to some. At 4:30, he was still muttering to himself, and it sounded like he was crying. So very sad . . .

4:45. He's getting louder again. "Am I good enough now?" "Hold your heads up!"

5:00 PM. He's still ranting, cutting up something and throwing pieces into the grass between his tent and the river, making references to Dylan, and preaching about Jesus Christ, saying something about why he created the world the way he did.

6:45 PM. There's been a rainstorm, the sun is back out, and he is still walking about in the tall grass along the river preaching. I am exhausted - can't imagine how he keeps going.

8:30 PM. Someone is cutting wood directly across the river from my apartment. Not with a chainsaw this time – with an axe, obviously. Also, the woman mentioned in 5/28/2024 entry has tied her dog to the small tree on our property again. It is in distress and barking non-stop. We know this woman is from the encampment, because the usual guy with the Alumicraft boat drives past The Landings and has been picking her and the dog up, and then returning past us again. I called non-emergency about the dog tied to the tree, and then called again when the woman finally came back, grabbed it, and started south down the trail. I asked dispatch to have officers check for license and vaccination (the woman undoubtedly has neither), saying that I was bitten by a pit bull downtown last year and am still paying monthly for rabies treatment. I told the woman she cannot leave the dog tied up on this property, then videoed her and the dog as they passed under my balcony. This is not a small dog. It is stocky and muscular.
