Caroline introduced the following subrecipients who shared their successes from the 2014 CDBG program year.

David Reinhart from Building Inspections explained that CDBG funds are being utilized to fund a Code Enforcement Tech Position through August of 2016. This position is responsible to write orders to correct on various types of violations and has 83% compliance on the orders to correct.

Andrew Londre from Couleecap, a CDBG recipient, described their Co.Starters Program. A program developed for entrepreneurs looking to launch or reevaluate their microenterprise businesses. They were able to serve 20 businesses, 12 which were LMI.

Hamilton School Principal is excited about the positive buzz that has been generated by our replacement housing program. They have seen increase in parent involvement and middle class families moving to the area.

A motion was made by Becker, seconded by Kader to close the open forum.

Accept and file 2014 CDBG Consolidated Annual Performance and Evaluation Report

Caroline Neilsen summarized the 2014 Program Year CAPER, highlighting some of the specific accomplishments of the CDBG and HOME program. When asked how we were able to accomplish so much the past year, Caroline explained that the Community Development Program has been seeking partnerships, streamlining procedures by implementing new technology, looking to other Communities for guidance and the addition of TIF Districts have all assisted.

A motion was made by Kader, seconded by Becker to accept and file the CAPER. The motion carried unanimously.

#### 15-0669

Action on substantial amendment to increase CDBG loan for Roosevelt School Development to Gorman from \$250,000 to \$400,000. (Source of Funds: Small Business Development Loan Program).

Caroline Neilsen reviewed the attached memo and introduced Ted Matkom from Gorman Co via teleconference.

Ted Matkom explained Gorman Co is pursuing, on behalf of the Roosevelt School Project, a 4% tax credit development; creating approximately a \$300,000 gap from the original 9% tax credit development. Gorman is asking the City of La Crosse to increase their original proposed amount from \$250,000 to \$400,000. Due to the added increase of funds Gorman would also revise how the units are set up. The project would provide 32 units, all which would be for 60% AMI. Due to the funding sources, this would not be negotiable.

A motion was made by Kader, seconded by Turtenwald to approve the proposed amount of \$400,000 at 2% cash flow, 15 year term provided Gorman provides a cash flow statement forecast. The motion carried unanimously.
