NOTICE IS HEREBY GIVEN that the Common Council of the City of La Crosse by its Judiciary and Administration Committee will hold a public hearing upon the proposed change in the zoning ordinance hereinafter set forth. Such public hearing will be held at 7:30 p.m. on Monday, December 30, 2013 in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.
The City Plan Commission of the City of La Crosse will meet to consider such ordinance on Monday, December 30, 2013 at 4:00 p.m. in the 3rd Floor Conference Room in City Hall, the Committee of the Whole on Tuesday, January 7, 2014 at 7:30 p.m. and final action will be determined by the Common Council on Thursday, January 9, 2014 at 7:30 p.m., both in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.
Any person interested may be heard for or against such proposed change, and may appear in person, by attorney or may file a formal objection, which objection forms are available in the Office of the City Clerk.
Such proposed change set forth in the ordinance now pending before the Common Council of the City of La Crosse is as follows:
AN ORDINANCE to amend Section 15.02(B) of the Code of Ordinance of the City of La Crosse by transferring certain property from the Floodway Overlay District and Light Industrial District to the Public/Semi-Public District
providing for consistent zoning of park land and allowing for proper enforcement of restrictions on properties located at 301, 617, 700 Pettibone Dr. N. and 333 Park Plaza Dr.
