Such public hearing will be held at 7:30 p.m. on Monday, December 30, 2013 in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.
The City Plan Commission of the City of La Crosse will meet to consider such ordinance on Monday, December 30, 2013 at 4:00 p.m. in the 3rd Floor Conference Room in City Hall, the Committee of the Whole on Tuesday, January 7, 2014 at 7:30 p.m. and final action will be determined by the Common Council on Thursday, January 9, 2014 at 7:30 p.m., both in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.
