ORDINANCE NO.: 4830 AN ORDINANCE to amend Subsections 14.18 of the Code of Ordi-nances of the City of La Crosse to br-ing the Extraterritorial Plat Approval Jurisdiction in compliance with State

SECTION I: Subsection 14.18 is hereby amended to read as follows: 14.18 PLATS WITHIN THE EX-TRATERRITORIAL PLAT AP-PROVAL JURISDICTION.

The Plan Commission and Common The Plan Commission and Common Council may recommend—or approvale, conditionally approve, or deny the subdividing of lands in the extrater-ritorial plat approval jurisdiction based on the applicable criteria enumerated hereinafter. The Plan Commission may not consider any subdivision or may not consider any subdivision or land division which did not have prior approval by the approving authorities for both the Town(s) and La Crosse County. The Plan Commission may require any conditions in the approval of a subdivision or land division, including the use of any restrictive cov-enant. (2nd Am. Ord. #4162 -

(A) When the land to be subdivided lies within the extraterritorial plat approval jurisdiction of the City, the subdivider applicant shall proceed as specified in Sections 14.13 through 14.17 except transmittal responsibility lies with the City Clerk, Town Clerk or County Planning Town Clerk or County Planning Agency to whomever the plat is first submitted; and the subdivider shall indicate which one in his application.

(B) Approval agencies shall be as specified in Chapter 236 of the Wisconsin Statutes; and the subdivider applicant must comply with the land division regulations of said agencies or units of government.

(C) Subdivider Applicant may proceed with the installation of such

Stoo improvements and under such regulations as the Town Board of the Town within whose limits the plat lies may require, provided that none of Lisa Zobeck, being duly sworn, says that she is the principal clerk of the LA CROSSE TRIBUNE, a public daily newspaper of general circulation, published in the City of La Crosse, in the county and state aforesaid, and that the notice of which the annexed is printed copy taken from the paper in which the same was published, was inserted and published in the said newspaper on the
