

ORDINANCE NO.: 4843

AN ORDINANCE to amend Section 48-26(b)(7) of the Code of Ordinances of the City of La Crosse to correct the legal description of the Bluff Slough Slow No Wake Zone.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

SECTION I: Section 48-26(b)(7) is hereby amended to read as follows:

- (7) ~~There shall be a slow, no wake zone in that part of the waterway known as Bluff Slough, which is a backwater of the Mississippi River, located in the City of La Crosse and the Town of Shelby, legally described as: All that part of the East½ of the SW¼ and part of the West½ of the SE¼ of Section 8, Township 15 North, Range 7 West in the City of La Crosse and part of the NE¼ of the NE¼ of Section 17, Township 15 North, Range 7 West in the City of La Crosse and part of the NW¼ of the NE¼ of Section 17, Township 15 North, Range 7 West in the Town of Shelby described as follows: Commencing at the Northeast corner of said NW¼ of the NE¼ of Section 17, thence South along the East line of said NW¼ of the NE¼ 532 feet to the point of beginning; thence Northeasterly 350 feet more or less to the Southernmost corner of Lot 17 Huber Homes Addition, which is the lot line between 2808-2810 and 2816-2818 Huber Court; thence Northwesterly along the Easterly shore line of Bluff Slough (also known as Swift Creek or Running Slough) 2,300 feet more or less to the North line of Lot 5, Block 21 of Ed Clinton and Blackwells Addition, now vacated; which is the lot line between 2414 and 2418 13th Street South, thence Southwesterly at a right angle to the shore line 300 feet more or less to the Westerly shore line of Bluff Slough; thence Southeasterly along said Westerly shore line 2,550 feet more or less to the point of beginning.~~

That part of Bluff Slough located in parts of the NE ¼ of the SW ¼, SE ¼ of the SW ¼, NW ¼ of SE ¼ and SW ¼ of the SE ¼ of Section 8 and also parts of the NW ¼ of the NE ¼ and NE ¼ of the NE ¼ of Section 17 all being located in Township 15 North, Range 7 West, City of La Crosse and Town of Shelby, La Crosse County, Wisconsin more particularly described as follows:

That part of Bluff Slough being located South of the Westerly Prolongation of the North line of Lot 2, Block 21 of the Vacated Plat of Clinton and Blackwell's

Addition and North of the Southwesterly Prolongation of
the South line of Lot 17 of the Huber Homes Addition.
Said No Wake Zone is 0.5 miles in length more or less.

SECTION II: This ordinance shall take effect and be in
force from and after its passage and publication.
