**ORDINANCE NO.: 4797**  
AN ORDINANCE to amend Section 15.17(A) of the Code of Ordinances of the City of La Crosse to allow restaurants and concessions as a permitted use on City park land in the Public and Semi Public Zoning District.  
15.17 PUBLIC AND SEMI-PUBLIC DISTRICT REGULATIONS.  
(A) USE REGULATIONS.  
In the Public and Semi-Public District no land shall be used except for the following uses:  
(1) Governmental Offices and facilities.  
(2) Elementary and secondary public and private educational facilities.  
(3) Historical structures.  
(4) Public parks, community gardens and plazas.  
(5) Off-street parking and loading facilities.  
(6) Public auditoriums.  
(7) Hospitals and clinics occupied by a minimum of twenty-five (25) physicians or dentists practicing medicine or practicing dentistry.  
(8) Conditional uses as provided in Section 15.26. (Ord. #3673 - 3/13/97)  
(9) Post-secondary public and private educational facilities. (Ord. #3213 created 5/10/90 #3695 - 4/10/97)  
(10) Publicly owned and operated airports and aviation-related facilities as well as non-aviation related facilities, provided that Section 13.03(D) is adhered to. (Ord. #3861 - 10/14/99)  
(11) Restaurants and concessions that are located on City owned park land and subject to approval by the Board of Park Commissioners.  
SECTION II: This ordinance shall take effect and be in force from and after its passage and publication.
