- No person shall keep any rooster.
- No person shall slaughter any chickens.
- Chickens shall be provided with a covered enclosure and kept in covered enclosure or a fenced enclosure within the backyard of the property at all times.
- No enclosure shall be located closer than 25 feet to any residential structure on an adjacent lot.




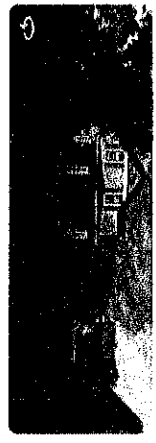

Attached are the plans of the chicken coop we will be building. I have reached out to see if a building permit is required and will submit the application if needed, I'm waiting on a call-back from Eddie in that department.

The neighbor due east of the coop has an 8' privacy fence. We are in the process of replacing our fence to a 6' privacy fence via Weid Investments. The permit has been obtained and the fence is due to be installed in the next couple weeks. The rest of the back yard is fully fenced.

The chickens will always be kept in a covered run in addition to being kept in a fully fenced yard.

I mailed in an application about a month ago, but the check hasn't been cashed. I contacted the City Clerk and Jonah said they do not appear to have received that first application.
