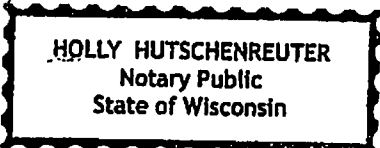

**ORDINANCE NO.: 5128.**  
 AN ORDINANCE to amend Section 2-604 of the Code of Ordinances of the City of La Crosse adding a member to the La Crosse Center Board.  
 THE COMMON COUNCIL of the City of La Crosse do ordain as follows:  
 Section I: Section 2-604 is hereby amended to read as follows:  
 Sec. 2-604. Membership and organization.  
 The La Crosse Center Board shall consist of nine (9) members who shall be qualified electors or residents of the City, except that if the Mayor appoints a representative of the La Crosse County Convention and Visitors Bureau to the La Crosse Center Board, that appointee need not be a resident of the City of La Crosse. One member shall be a Council Member and one member shall be a County Board Supervisor. All members of the Board shall be appointed by the Mayor subject to confirmation by the Common Council. Board members shall be appointed for terms of three-year terms, except the Council Member and County Board Supervisor which shall be for a two-year term.  
 The position of Board member emeritus is hereby created for Mayor Patrick Zielke's years of service to the La Crosse Center Board. This position serves an honorary non-voting board member; shall receive all information that regular board members of the La Crosse Center Board receive; may attend all board functions; may participate in all discussions related to board matters; shall not fill in as a voting board member when other members are absent; and shall abide by the provisions of the ethics ordinance as applicable to regular board members. Attendance of board member emeritus at a board meeting shall not be counted toward completing a quorum of the board; attendance at board meetings is optional to the emeritus member.  
 SECTION II: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of the article shall not be affected.  
 SECTION III: This ordinance shall take effect upon passage and publication.
