AN ORDINANCE to amend Sub-section 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Commercial District to the Multiple Dwelling District allowing for a new development consisting of five townhomes at 1300 State Road 16.  
THE COMMON COUNCIL of the City of La Crosse do ordain as follows:  
SECTION I: Subsection 115-110 of the Code of Ordinances of the City of La Crosse is hereby amended by transferring certain

tract to the Multiple Dwelling District on the Master Zoning Map, to-wit: 17-10491-10.
