Such public hearing will be held at 7:30 p.m. on Tuesday, June 3, 2014 in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.
The City Plan Commission of the City of La Crosse will meet to consider such ordinance on Monday, June 2, 2014 at 4:00 p.m. in the 3rd Floor Conference Room in City Hall, the Committee of the Whole on Tuesday, June 10, 2014 at 7:30 p.m. and final action will be determined by the Common Council on Thursday, June 12, 2014 at 7:30 p.m., both in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.

Any person interested may be heard for or against such proposed change, and may appear in person, by attorney or may file a formal objection, which objection forms are available in the Office of the City Clerk.

Such proposed change set forth in the ordinance now pending before the Common Council of the City of La Crosse is as follows:

AN ORDINANCE to amend Subsection 15.44(E)(4) of the Code of Ordinances of the City of La Crosse transferring certain property from the Commercial Land Use Category to the Downtown Land Use Category at 529 Park Plaza Drive on the Future Land Use Map in the Comprehensive Plan.
