This is a quotation and agreement on the goods named, subject to the conditions noted below:

1. Price includes panels, stands, and weights / weighted every other panel. Includes 1 set-up and removal. Any other moves to be billed on an hourly basis, including but not limited to, re-installation necessary due to high winds blowing the fence over. Price is per lineal foot. Actual footage may vary based on how Customer would like fence set-up.
2. Minimum lead-time of 5 business days for set-up and removal.
3. Customer will be billed upon installation. No prorated credit will be issued. Payment terms are Net 30 days.
4. The customer agrees not to cause equipment to be removed from job location without specific written consent from Fence Bros., LLC.
5. The customer agrees to exercise care in the use and handling of equipment and will be responsible for any damages to equipment. Customer is responsible for the replacement cost of the equipment, if complete loss occurs, including fire and theft. Replacement cost of a standard

fence panel is \$140. Regardless of any payments made as contemplated herein, the fence panels at all times shall remain the property of Fence Bros., LLC

6. If screening and/or signage is affixed, fence panels are vulnerable to high winds even if additional weights and/or support is added. Customer assumes responsibility for any fence panels that need to be reinstalled. Fence Bros can reinstall for additional mobilization and installation fee.
7. This Agreement will commence on the day fence is delivered to Customer and will terminate upon removal or return of fence from Customer in good condition. It is the Customer's responsibility to schedule removal service or return of fence.
8. Customer shall not (a) allow any lien, charge or encumbrance to be levied against the fence; (b) sell, dispose of, transfer, assign, pledge or relocate the fence; (c) allow others to take or assume possession of or control over the Fence or allow it to become affixed to any real property; (d) allow any alteration of or diminution to the fence; (e) obtain, pay for and maintain all necessary licenses, permits and permission for Customer's use of the fence. Customer shall comply with all lawful laws, rules, regulations, and orders of any authority having the power to regulate police or supervise the possession, use or maintenance of the fence.
