McArdle and McKnight presented. There was a suggestion to have a gardening club maintain landscaping around Eagle sculpture. Board questioned if work on Dancers could be done off-site and if base was needed. It would be good to have Dancers removed by Artspire. CM Janssen asked about powder coating for Lyra, suggested getting a quote from Fairway Painting and Sandblasting, Inc. Board requested update on committee discussing Hiawatha. Parker suggested recommendation to make a decision on location as soon as possible due to deteriorating state. CM Janssen suggested recommendation on how frequent maintenance would need to be done to be in good condition. Parker suggested recommendation for funds or budget for arts board to maintain public art.

Record made a motion to approve the conditions report with the discussed edits and submit to Board of Parks Commissioners and Board of Public Works; Williams seconded. The motion carried by a voice vote.
