ORDINANCE NO.: 5164
AN ORDINANCE to amend Sub-section 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Single Family Dwelling District to the Public/Semi-Public District allowing new fire station at 1532-34 and 1540 Liberty St. and 1539, 1543, 1547 and 1553 Charles Street.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

SECTION I: Subsection 115-110 of the Code of Ordinances of the City of La Crosse is hereby amended by transferring certain property from the Single Family Dwelling District to the Public/Semi-Public District on the Master Zoning Map, to-wit:

- FIRST ADDITION TO P.S. DAVIDSONS ADDN
- Tax Parcel 17-10104-40. S 1/3 LOT 4 & ALL LOT 5 BLOCK 13
- Tax Parcel 17-10104-30. S 2/3 LOT 3 & N 2/3 LOT 4 BLOCK 13
- Tax Parcel 17-10105-50. LOT 19 BLOCK 13
- Tax Parcel 17-10105-60. LOT 20 BLOCK 13
- Tax Parcel 17-10105-70. LOT 21 BLOCK 13
- Tax Parcel 17-10105-80. LOT 22 BLOCK 13

SECTION II: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.

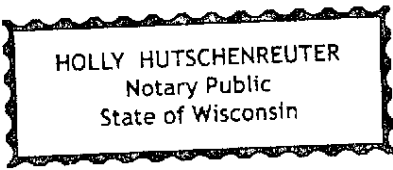
SECTION III: This ordinance shall take effect and be in force from and after its passage and publication.
