Dear Mayor Washington-Spivey and Council Members,

As a resident of La Crosse, I am writing to express my concern about the potential closure of the Northside Library and Northside Pool. I understand that our city is facing a significant budget deficit and that difficult decisions must be made. However, I urge you to preserve these essential community resources, which provide immeasurable value to La Crosse residents—especially children and working families.

Hello city council members,

I am writing to express my concern regarding potential closure of the north side library and community pool. Both the library and pool are highly valued resources in La Crosse, and I urge you to consider an alternative to taking them away from children in our community. Library programs such as play shoppe, story time, and after school club serve as a safe space for children to learn, create, play, and connect in a space where they feel safe and welcomed.

A 2019 study published in the Journal of Community Health discusses the impact of public libraries as a resource for reducing place-based health disparities. The authors examine how public libraries address social determinants of health, such as “social exclusion” through providing safe spaces for vulnerable groups such as LGBTQ+ youth, or “work and unemployment” through providing job training programs and resume preparation classes, or “stress,” through hosting workshops and exercise classes. I have attached a link to the study below.

Clearly, our public libraries provide so much to our community, but can only provide these resources as long as they are properly funded. Again, I urge you to consider an alternative to eliminating the library and pool from the north side. Thank you for your consideration.

My name is Sarah Yehle. I recently heard about due to budget cuts, the North community library and the Northside pool are at risk for being permanently closed. I am writing today to ask to consider amending this decision.

A little background on me and why I personally feel these are two important places to keep for the Northside of La Crosse. I grew up on Loomis Street. I attended Roosevelt Elementary, Logan Middle, and Logan High School. And when school was not in session for the summer, the library and the pool were within walking distance for myself and 2 younger brothers to go to. I remember attending many library events, hanging with my friends while on the computers, finding my next good book to read, and participating in summer reading programs. And at the pool, of course there were tons of memories and fun to be had with friends (and making new friends too!). During the school year while I was in middle school, the library was on my walk home, so you could often find me at the library after school. I have very fond memories growing up because of these places. Part of why I am still an active reader as an adult I contribute to from this library, it fostered a love of reading starting at an early age. These were two safe places for me to entertain myself, especially when I came to an age that I could go by myself and find independence. So why would we take away that opportunity from current and future generations of children?

I have concerns that there will be next to nothing for children and families to do if the pool and library were gone. I hear of talk of wanting to bring in young families to La Crosse and rejuvenating the Northside, which I think is great. But how will that be achieved realistically if these places are gone? These places are a part of the foundation to creating a sense of community to the Northside. What are children and parents supposed to do for entertainment, especially in the summer? Nothing? I especially worry that instead of swimming or going to the library, children may get bored over the summer months and cause trouble in their neighborhood instead. To Whom it may concern:

I am writing this letter to voice my concern about the upcoming closure of Logan pool and the library. I live two blocks from each facility and have used the pool about 10 times this summer and the library several times. Since the hours were expanded at the library, I noticed it was full every time I went there. The pool was also filled with people, and I often see groups of children walking to the pool. I am concerned that taking away these services in an underserved community will greatly impact the community. I grew up on the north side and remember the time before we had a pool as a child. We were able to walk anywhere back in those days, and I still think it was not safe at the beach. The northside beach is not a good option for kids to go to with inadequate supervision and needing to cross a busy road to get there. I would not let my children go to the beach.. Many of the families in the neighborhood do not have the means to drive to other areas to find pools. I think this is a grave misjustice closing these facilities down.

I know there is a limited budget, but we need to look at how we are utilizing our resources. I am not against bike lanes, but as a bicyclist myself, I would not necessarily head downtown for a route. Often, I go to a trail or find a bike path. I have done the trail through the parks but recently have been more concerned about safety traveling the trails through the marsh, which I use to enjoy.

In a time when we are trying to balance everything, it feels like more services are getting taken away from the taxpayers of La Crosse. I moved away from the south side in 2015 when I was having a sidewalk placed through my boulevard. I could not fight that then, and even when they said the sidewalk would connect. It was an owner/occupied duplex. I lost a fence, invisible dog fence, tree and part of my front yard. 10 years later the sidewalk goes down the street and does not connect to another sidewalk. I call it the sidewalk "nowhere". I left for lower taxes in my parents' house on the north side since I knew the taxes would go up with the sidewalk. I have been by my place on the southside, and it looks horrible. I had maintained that property in great condition and have a hard time going by it now. We have a group of great neighbors but see that more people are putting houses up for sale. That means more landlord owned properties, and we all know how well some of those are maintained.

I am asking you how many people will use the bike lane versus a pool and library. I think we need to invest in our children. I am active with Trinity Lutheran Church, and we do Monday meals, block parties, clothes closet and donate to the elementary school. The churches are doing a lot for the community. I think it is time for us to take care of our taxpayers.

My current property assessment has gone up \$60 in two years without an assessment.. I live in a 120-year-old house with older water heating. My two daughters have left La Crosse recently for Onalaska. I am concerned more people will leave the city with the loss of services we are experiencing.

I am a proud northsider and am trying to be a good neighbor in my community. I retired from Gundersen Health and currently work one day a week at the Northside Neighborhood Clinic, which is also trying to help underserved patients. I am asking you not to forget the northside. I have had several offers to sell from rental businesses. I would really like to stay where I am, but may consider alternatives if we keep losing services as taxes increase. I am asking you to reconsider your plans to close the pool and the library.

Dear La Crosse city council members,

I am writing this email to urge you to support ongoing funding for the Northside library and the Northside pool so that they may remain open and accessible to our community. Please consider the multiple examples I've listed below as evidence that these facilities are vital to our fragile Northside community and give them your ongoing support.

My husband and I are proud 2nd generation members of the Logan middle and Logan high school families and now have 2 of our 3 children attending Logan middle school. The pool is used yearly as a celebration for middle schoolers to enjoy a pool day at the end of the year - for many kids, this is the only chance they will have to attend a pool for the rest of the summer. Extra pool time is also used as a reward to help motivate our middle schoolers to participate in positive behavior and school attendance, and in reaching fundraising goals. Access to the pool negates the need for a costly bussing fee to take a field trip elsewhere. As a PTO parent I can assure you that there is minimal funding in the schools' budgets for this. Once summer starts, the pool provides a safe environment for kids to exercise, socialize, and otherwise avoid negative behaviors. Many of these children are coming from low income families where their parents are working multiple jobs and are unable to transport them. Being able to access the pool with a short walk is essential. They do not have the means to instead go to a pool on the south side of La Crosse, Onalaska, or Holmen. Many of the children receiving childcare services at the Boys and Girls Club look forward to their weekly pool day, again where they can walk a few blocks and have a chance to experience a fun pool afternoon or swimming lessons they otherwise would not have.

Loss of library services is a heartbreaking reality we have already experienced in this city. The Northside library is an important safeguard for so many kids in our schools. It provides them a place to go after school for a quiet environment to do homework, a place to get a snack, and a place to be with friends or get some social support from the caring employees of the library. Many of them may otherwise be returning to an empty house. Northside community members with lack of access to transportation need the library as an important institution not only for access to reading materials, but to access internet services for job applications, to maintain benefits, and so many other essential services of daily life.

As a tax payer of La Crosse, I cannot stress enough how important these facilities are to our family and countless other families in the Northside community. The fact is that our family could easily choose to move to one of the surrounding cities and pay less in taxes for more abundant services while sending our children to schools that are currently seeing more growth and stability. This is something we have considered. However, we feel a strong connection to La Crosse and the people that make up this community, as well as an obligation to stand up for our neighbors who do not have the same means to make another choice when essential services are taken away. I hope you can see how extremely important these facilities are to our community, and find a way to maintain them.

Dear City Council Members,

I am writing to voice my opposition to closing the Northside Library and the Northside Pool. I grew up attending Logan Middle School and Logan High School. The Northside Library was a valuable resource to me growing up, and it continues to be valuable to the current Northside residents. The same is true for the pool, it gives kids somewhere to go in the summer that is close to home.

I am a CPA who has worked at UW-La Crosse and Western Technical College, so I understand the difficulties of balancing budgets. I looked up the Library's 2025 budget online and saw \$325,000 was budgeted for books and publications. Perhaps this number could be reduced by \$100,000 to help cover the \$175,000 shortfall? I also looked at the 2025 City of La Crosse General Fund budget, and saw the budget for personnel and contractual services was 60 million dollars. Perhaps there are some other small reductions in that number that could be made to help the Library.

I also looked at the City's 2025-2029 capital budget and saw there is \$900,000 in the capital budget for Logan Pool. Why is this being taken out of the capital budget? It seems inequitable to have put almost 4 million dollars in the Memorial pool 5 years ago, but now do not have any funds for the Northside Pool.

One final point: While I realize the Council ultimately voted down the additions of a City Administrator or Operations Director, many of us questioned why you would even entertain the possibility of adding a City Administrator or Operations Director when you are also considering closing a library and pool? One of those positions costs as much if not more than the \$175,000 needed to keep the Northside Library open. I believe keeping the Northside Library and Pool open is vital to our community.

At last night's listening session I was hoping to have more council members there to hear the community share how important these two are to the northside. Now I know you are all busy, so I wanted to share some of the things I heard.

Not only does the pool and library provide a safe place for the children to visit, but they also provide a social and educational environment.

As you know, the northside is not an affluent area of the city. With the library so close to the schools it is used by many of the kids. The length of the city and the routes that need to be taken on the overhead and railroad tracks, it is not safe for children to ride their bikes to the library downtown or either of the pools.

A couple of parents said that when they asked the kids, on a scale of 0-10, how important it is to keep the two open. They said it was an 11.

Technology and physical exercise is a focus these days.

- The library is a free place children can go to do their homework when there is no computer in their home.
- The pool gives the children and adults a chance to exercise, without even realizing it is exercise.

I realize every area needs to make some cuts. I'm hoping that you can take into consideration the cut the northside made within the last few years to make sure one of the other pools received additional funding.

We understand there may be the possibility of having the pool needs come out of the capital improvement budget. It would be prudent to take that into consideration and not eliminate the NS pool from this year's budget.

If a pool is removed:

### 1. Public health and recreation decline

Fewer safe, affordable places for exercise—especially for kids, seniors, and low-income families.

Can increase risks of obesity and heat-related illness in summer.

### 2. Youth and community impact

Teens and kids lose a structured, supervised space—sometimes leading to more unsupervised or unsafe activities.

Swimming lessons and lifeguard training programs disappear, which can increase drowning risks over time.

### 3. Economic effects

Local businesses near the pool (ice cream shops, gas stations, etc.) may see a drop in summer revenue.

Property values can slightly decline, since nearby recreation amenities often boost desirability.

### 4. Community cohesion weakens

Pools are social hubs for neighborhoods—without them, community interaction and sense of belonging can decrease.

If a library is removed:

### 1. Educational access declines

Students, job seekers, and seniors lose free access to books, internet, and learning programs.

Digital divide widens—especially for those without internet or computers at home.

### 2. Economic & employment effects

Fewer resources for job hunting, resume help, and adult education classes. Taxes.

Lower community literacy and fewer spaces for tutoring or small business work.

### 3. Social and cultural loss

Libraries serve as safe, quiet gathering spaces for all ages.

Community events, workshops, and children's storytimes disappear, reducing social connection.

### 4. Long-term community decline

Neighborhoods often become less vibrant and less attractive to new residents.

Civic engagement can decrease, since libraries often host meetings, voter info, and local notices.

Unfortunately, tho I empathize with people wanting to save the North Branch Library (my first library 70 years ago), not even the LPL & Archives answers many questions these days about anything I've asked them. That downtown library is undergoing reconstruction this year, & physical access by patrons to that archives is impossible. The archives answers queries 4 hours/day via phone &/or e-mail approaches, But when the main library is out-of-commission basically so long, it's hard to find out much about any city business, unless you subscribe to the LaX Tribune or view local news on TV. If you check records, you'll find the North Branch Library was my first neighborhood library, when I was 4-5 years old; I'll be 75 y-o this Nov. 25. Also, I am likely Wisconsin's alltime most-prolific book-author/photographer, & tho some US authors have authored/published more books than I have, e.g. LRonHubbard did nearly 1900 books during his lifetime, but almost all were sci-fi books. I've done more than 400 books so far, & counting, including 325+volumes of my series Spirit of America. Unlike most authors tho, mine have been in every literary & photo genre. Given that the North Side has the Harry J. Olson Senior Center and the North Side Community Center, why do we need a North Side Library as well as a Main Library? Shouldn't our goal as budget-conscious citizens be to ensure that we do things as efficiently and inexpensively as possible? The answer is that a community Library is more than a gathering place, it serves as a source of curated information, a quiet space for study and reflection, assistance with job searches, and much more.

Many North Side residents lack reliable home internet, making the library's free broadband essential for daily tasks, job applications, and online learning. Given its location next to the North Elementary School, young students need a place close by to access the library's computer and the other libraries services. It is not only a safe and quiet space for study but it provides easy access to curated, and accurate resources. The internet is filled with equal amounts of information, much of which is inaccurate or outright false. Librarians can guide young (and mature) people to good sources of information. They can assist students in developing the life-long skill of sorting the "wheat from the chaff".

These skills are important to young and old; we all at some time need to remember and sharpen our critical thinking skills and our ability to find and recognize the most accurate information. Librarians are well equipped for this task.

Libraries by design and mission are assessable to persons of all ages. They offer a quiet, welcoming environment for study, relaxation, and shelter from the weather, acting as a de facto community center. Libraries combat isolation by offering a sense of communities.

Hello, my name is Kathi Blanchard. I am a proud lifetime resident of the Northside of la Crosse. I am also a business owner on the Northside. As a child I spent many days at the old Logan pool and at the North Branch library. These were two places that my parents let me gain a little independence and grow as a young person. Supervised programs, safe environment to explore. I was also raised in a single parent household with no extra money for fun programs ( the YMCA and Park and rec), I learned a love for reading at the library from my dad who would take us to the main branch every weekend, and showed me the pleasure of reading, but I couldn't use the main branch on my own as a young child because it was too far from my house. That is when he showed me the North Branch library.....only 6 blocks to walk....easy to get to and easy to use. I could easily walk there after school and the librarians would even help me with school work if they were able to, learning how to use the Dewey decimal system to find research materials was a very important tool. When my husband and I bought our home before we had children we knew it was going to be in the Northside part of town. Our home is 3 blocks from this library, 3 blocks from the pool....perfect for when we would have children to utilize these resources. The library was the first place I felt was a good starting point for our children to earn some independence on their own. Located conveniently kitty corner from their elementary school. They would walk over after school and enjoy activities there, computer use, video games, board games and reading. They would meet up with friends to just hang out. Some kids are latchkey kids and simply don't want to be home alone. Our kids are lucky we have Internet at home, but many of their friends do not so they need the access to this location so they can complete homework on their school issued iPads. If you go into the library you'll see adults also using the computers to search for jobs and check emails. Closing this branch would close off so many opportunities for neighbors and residents on the Northside. The pool is also an important feature on the Northside and a great selling point to

people looking to move to this area. Let's face it, the Black River beach is not a safe environment for kids. It's not watched with lifeguards, there's weeds and trash and even used needles in the sand, and the water is not safe to swim in most of the time. The pool gives affordable lessons to beginning swimmers, and water exercise to seniors. Its a refreshing respite in the heat of the day to many who need an oasis in their own town. I realize that every city has a budget and sometimes decisions get made on a spreadsheet and not on emotions, however I think that as a resident and a tax payer there are other areas that could be trimmed to safe these two features on the north side. We on the Northside get the short end of the stick on most city decisions, let's remember that WE are also residents of the city of La Crosse and we deserve to be treated equally. We would normally go to the Main Branch, but it was easier to ride our bikes to the South Branch. I was sad when a decision was made to close this location, but we still had the Main Branch available.

The Northside does not have another library. It does not have another location to redirect people to, unless they want to drive across town to utilize the Main Branch. Or drive to the Onalaska Library. The only problem with that is lack of transportation or ability to get to said locations.

It isn't a secret that the Northside is one of the most poverty-stricken areas in the Coulee Region. Many don't have transportation, many are paycheck to paycheck and many need assistance. Having a community resource so close for so many is such a benefit. Some people don't have access to computers to apply for jobs or obtain resources; the library helps with this.

Everything the Northside community has is being taken away or has become extremely limited. The local grocery store is either Kwik Trip or WAFER. I understand that there is a need for every department to reduce spending, but closing both the NS pool and NS library is basically telling NS tax payers that they don't matter. Last year there was money allocated to fix the Logan pool. I've been told by a council member that the Erickson Pool estimate for repairs was significantly more than what was budgeted for, so the money allocated for the Logan pool was moved to help the Erickson pool expenses. The construction was already being worked on and money needed to be found to pay for it. I completely understand why that reallocation from the Logan pool to the Erickson pool needed to happen. What I don't understand is why that wasn't taken into consideration for this year's budget. Of course the NS pool has maintenance issues because last year's budget was taken away.

After attending last night's board meeting I walked away beyond disappointed, not just in the vote but in the lack of information about where library funds are actually going. The Northside Library is only open approx.. 27 hrs per week, and accounts for approx.. 10% of programming to the best of my understanding. Last night it was mentioned that moving forward "Outreach" would focus on the unsheltered and proving possible vending machines (big price tag) and a mobile book van to go out into the community. None of which are cheap to pursue. How will this be funded? There was also talk about usage, with very limited hours at the Northside. The real question is how do you adjust programming to meet them where they are and with what they need? While my email will not change anything from last night, my hope is that you will take another opportunity to listen to your community/tax payers and find options that meet the need. What we don't need is a Service Provider who has forgotten the core of who they serve. Education like poverty, becomes generational. We need opportunities to encourage our young people when their home lives do not. Lastly, community seniors also need this connection, they are often forgotten. Let's not do that. And, yes, I do have a library card. I admit I have not been a frequent user, but the my kids and my Grandkids have spent many hours at the library.

To our City Council Members, I included you in this email as I have a question...Why is it the council has the power to approve or not the library budget, but the library board has the power to close/discontinue a service location? Why does the board have more power than other committees or commissions and the council? As a taxpayer, I voted for a council person and a Mayor. My expectation was they would make critical decisions for our community, that an appointed board would not have the power to shut down a service location. I humbly request you do not approve the budget and ask that they come back with viable options to meet the community need. You may not have the authority to say what they spend the budget dollars on, but again as a taxpayer, I expect you are holding them accountable. I think a budget of 5Mil +, we can do better.

I appreciate your time and efforts on our communities behalf.




