

Survival Budget:

Bare-minimum budget

Does not allow for any savings

Note - Housing Costs (\$416-\$700)


This budget does not include a cell phone

What does it cost to afford the basic necessities?

This bare-minimum budget does not allow for any savings, leaving a household vulnerable to unexpected expenses. Affording only a very modest living in each community, this budget is still significantly more than the Federal Poverty Level of \$11,670 for a single adult and \$23,850 for a family of four.





United Way ALICE Stability Budget

Jobs which (on average) pay less than the survival budget income requirement for 2 working adults (w/ two kids)

Approximately 90 of the 154 wage survey jobs have average wage below stability budget!

Approximately 10,040 of the 14,021 jobs surveyed fall below the hourly wage of \$25.67




Impressions on Wage Study

Wages do not equal total compensation (health care benefits, profit sharing, retirement investment matching, etc.), but do help illustrate levels of compensation

Of the 154 jobs presented, not all jobs fields employee the same amount of people: Ex: Bank CEO vs. Nurse

Child care is a HUGE Expense for families!
