Mayor Kabat provide an update to the Commission. He stated that there was an \$8 million threshold to reach and that he met with staff and department heads and was able to meet that threshold. Warren Thomas requested that Item #28 (Stations Facilities Assessment) be added back into 2016 as the study is intended to assist the Fire Department in bringing the fire stations into ADA compliance.

Richard Becker moved to bring Item #28 (Stations Facilities Assessment) back into 2016 and change the funding source to 10. James Cherf seconded. The motion passed 5-0.

Andrea Richmond requested that \$100,000 get moved back into 2016 for floodplain mitigation of the northside. Randy Turtenwald moved to split the source of funds for item #107 (Contracted Maintenance Practice) with \$157,500 as a source of funds 4 and \$157,500 as a source of funds 27 and to put #103 (Northside Flood Plain Improvements) back in 2016 with \$100,000. Richard Becker seconded. The motion passed 5-0.

Richard Becker moved to put the remaining \$153,500 into streets and to allow Dale Hexom to identify which streets it gets used for. James Cherf seconded. The motion passed 5-0.

Richard Becker moved to approve the budget as amended. James Cherf seconded. The motion passed 5-0.
