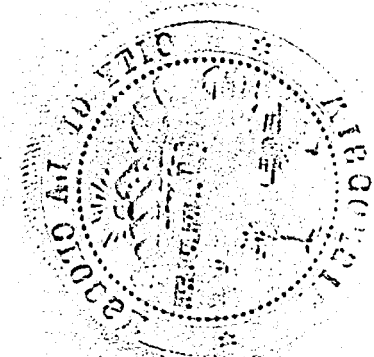

WHEREAS, such vacation should be done as expeditiously as possible.


NOW, THEREFORE, BE IT RESOLVED, by the Common Council, City of

Proposed Alley Vacation

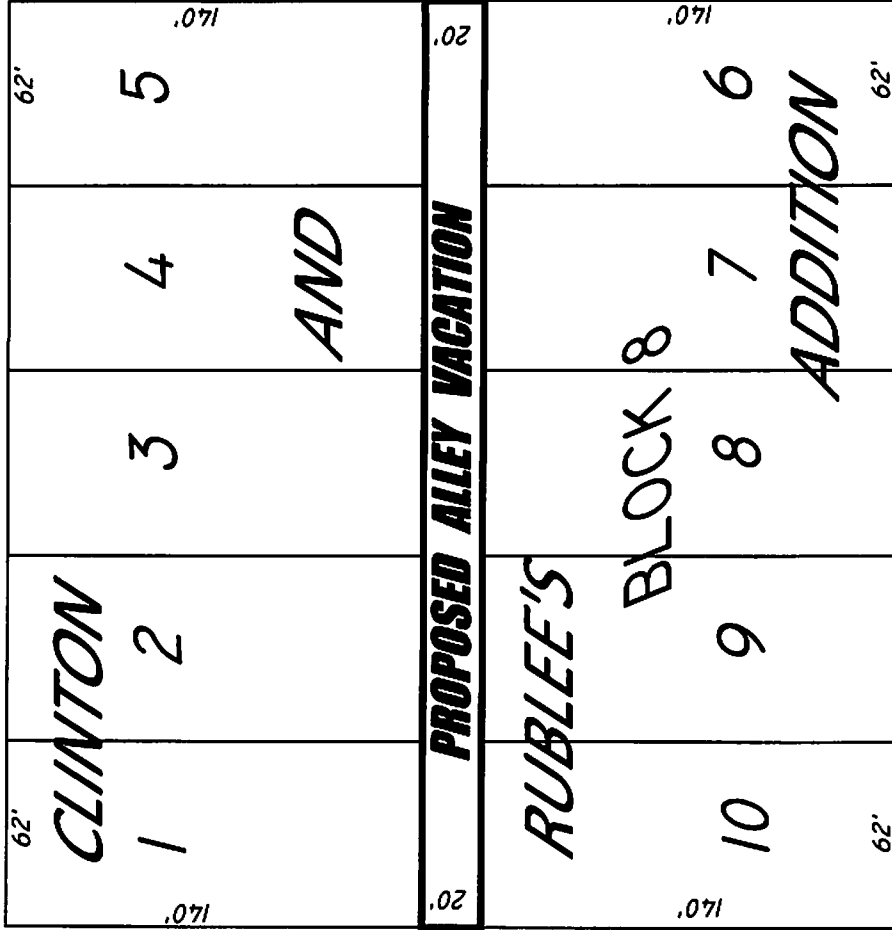
