MEMO: The intention of the author is to allow sufficient funding in 2021 for the A & E phase of the proposed changes to City Hall lobby area, complete with floorplans and renderings which convey clearly and completely how public access to City Hall (anywhere the public was permitted pre-COVID-19) will be temporarily or permanently altered post-construction. It is hoped that the Mayor and staff conduct a series of public information and input sessions (once safe to do so) presenting the new renderings, layout, and policy to the public and council for feedback prior to Council reaffirming inclusion of the balance of this project in the 2022 CIP in future budget proceedings.
