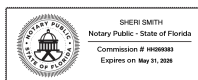

### NOTICE OF ORDINANCE NO. 5338

AN ORDINANCE to repeal and recreate Chapter 115, Article V, Division 2 Floodplain Zoning, Sections 115-207 through 115-312 of the Code of Ordinances of the City of La Crosse.

Please take notice that the above Ordinance was adopted by the Common Council of the City of La Crosse on June 16, 2025. A summary of the subject matter and main points of the ordinance is as follows.

Ordinance 5338 repealed and recreated Sections 115-207 through 115-312 and will put the City Ordinances regarding floodplain zoning in compliance with Department of Natural Resources floodplain regulations.
