SUPERINTENDENT OF STREETS

1. APPLICANT MUST BE A RESIDENT OF THE BLOCK FOR WHICH A PERMIT IS APPLIED.
2. APPLICANT MUST HAVE WRITTEN CONSENT OF ALL RESIDENTS OF THE BLOCK.
3. NO ALCOHOLIC BEVERAGES SHALL BE CONSUMED ON ANY PUBLIC STREET OR ALLEY RIGHT-OF-WAY.
4. ACCESS TO THE STREET OR ALLEY MUST BE GIVEN UPON REQUEST OF ANY RESIDENT OF THE BLOCK.
5. IF BARRICADES ARE REQUIRED FOR SATURDAY OR SUNDAY ACTIVITIES, THEY MUST BE PICKED UP AT THE MUNICIPAL SERVICES BUILDING, 2000 MARCO DR., ISLE LA PLUME, PRIOR TO 3:00 P.M. FRIDAY AND RETURNED NO LATER THAN 3:00 P.M. MONDAY. FOR MID-WEEK ACTIVITIES, BARRICADES MUST BE PICKED UP PRIOR TO 3:00 P.M. ON THE DAY PRECEEDING THE EVENT AND RETURNED BY 3:00 P.M. THE DAY FOLLOWING THE EVENT.
6. APPLICANT IS RESPONSIBLE FOR PICKUP/RETURN OF BARRICADES. IF CITY SERVICED, A FEE WILL APPLY.
7. APPLICATION FOR PERMIT MUST BE RECEIVED AT THE DIRECTOR OF PUBLIC WORKS OFFICE AT LEAST THREE FULL BUSINESS DAYS PRIOR TO THE EVENT.
8. THE APPLICANT WILL POST A \$100.00 DEPOSIT TO INSURE THE RETURN OF THE BARRICADES AND SITE CLEAN-UP. THIS DEPOSIT WILL BE RETURNED UPON SATISFACTORY RETURN AND INSPECTION OF THE BARRICADES AND THE SITE. DROP OFF DEPOSIT AT THE STREET DEPARTMENT (MUNICIPAL SERVICE CENTER, 2000 MARCO RD.) WHEN PICKING UP THE BARRICADES.
9. THE CITY NOISE ORDINANCE SHALL BE ADHERED TO. BLOCK PARTIES SHALL NOT START BEFORE 10AM AND SHALL BE CONCLUDED NO LATER THAT 11PM.
