SECTION I: Section 38-1(d) is hereby amended to read as follows: (d) Upon completion and the filing of the report, prepared by the Board of Public Works, with the City Clerk, the City Clerk shall prepare a notice stating the nature of the proposed work or improvement, the general boundary lines of the proposed assessment district, a place at which the report may be inspected and the place and time at which all interplace and time at which all inter-ested persons, or their agents or at-torneys, may appear before the Highways. Properties and Utilities Committee Finance & Personnel Committee of the Council and be heard. The notice shall be published as a Class 1 notice, under Wis, Stat.

ch. 985 and a copy of the notice shall be mailed, at least ten days before the hearing, to every inter-ested person whose post office ad-dress is known, or can be ascertained with reasonable diligence. The notice and hearing require-ments under this section do not apply if they are waived, in writing, by all the owners of property affected

by the special assessment.
