**ORDINANCE NO. 4856**  
AN ORDINANCE to amend Subsection 46-40(b) of the Code of Ordinances of the City of La Crosse to amend the reference to the Wisconsin Administrative Code.  
SECTION I: Subsection 46-40(b) is hereby amended to read as follows:  
46-40(b) Restrictions. No person, firm, or corporation shall establish or permit to be established or maintained or permit to be maintained any cross connection. No interconnection shall be established whereby potable water from a private, auxiliary, or emergency water supply other than the regular public water supply of the City may enter the supply or distribution system of said City, unless such

private, auxiliary, or emergency water supply and the method of connection and use of such supply shall have been approved by the City Water Utility and by the Wisconsin Department of Natural Resources in accordance with Wis. Admin. Code § NR 811.09 810.15(2).  
SECTION II: This ordinance shall take effect and be in force from and after its passage and publication.
