

Pump House Regional Arts Center seeks a street privilege permit to allow the following:

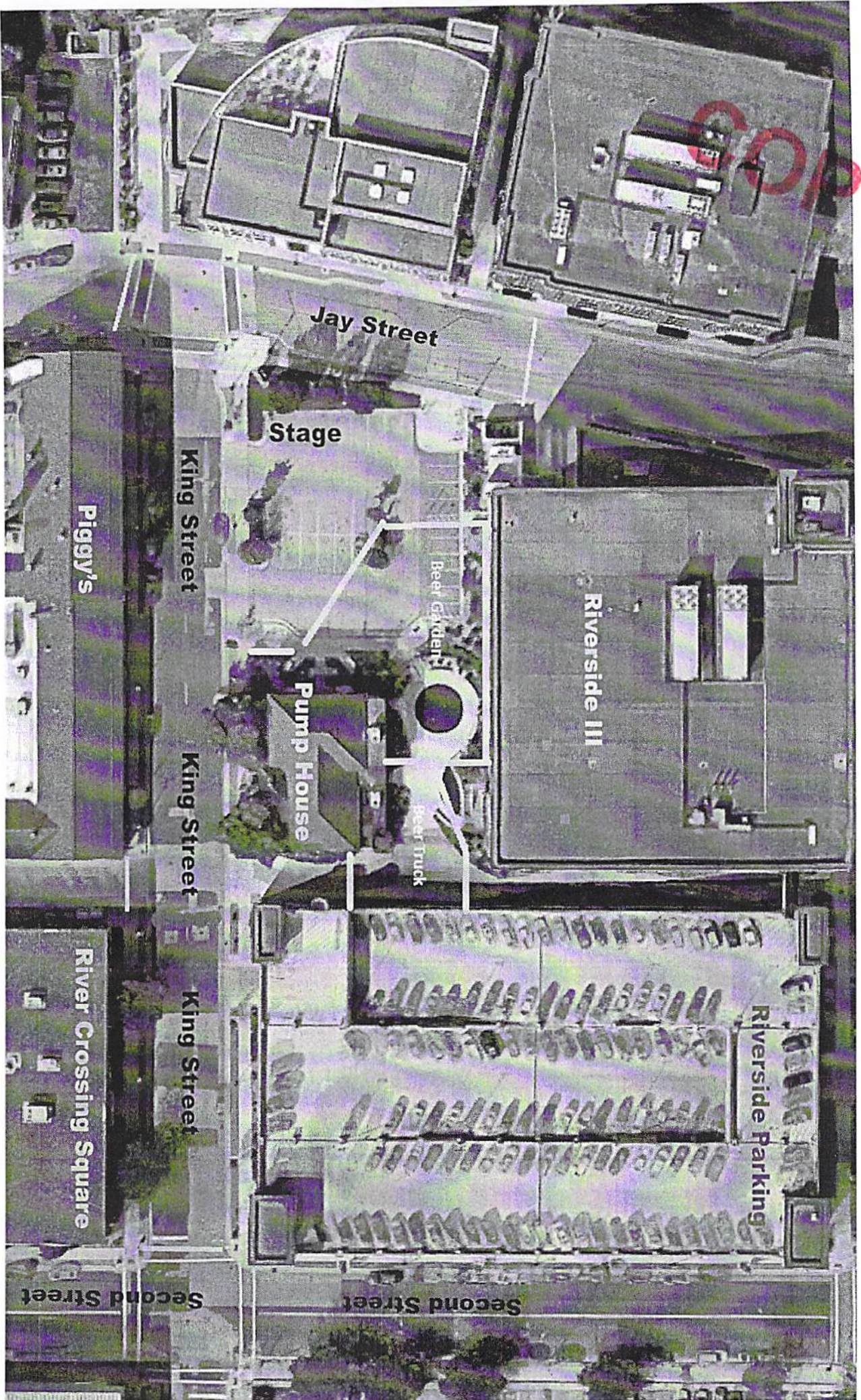
1. A block party event celebrating Explore La Crosse's "Bike Week," and the conclusion of Pearl Street Brewery's "Tour de Pearl," to be held on Sunday, September 4, 2016, 5:00 pm-10:00 pm, under the direction of the Pearl Street Brewery, Explore La Crosse, and Pump House Regional Arts Center.
2. Closure of King Street (from Front to Second Streets), the Pedestrian Walkway east of the Pump House (from King Street to Jay Street), and portions of Front Street (from King Street to the entrance of the Riverside III parking ramp on Front, between Jay and King) to vehicular traffic for Sunday, September 4, 6:00 am through Sunday, September 4, 11:00 pm for a street dance celebration, live music, and food and beverage vendors.
3. We have requested and received permission for a reroute and temporary traffic control of the Riverside parking ramp, east of the Pump House, on Second Street, between Jay and King Streets. We request appropriate signage and barricades for street, parking lot, and parking ramp closures to be dropped off on Friday, September 2.
4. We will receive written permission and approval from neighboring businesses, including permission from Piggy's to close the parking lot. We are working with La Crosse Public Works department on the parking ramp reroute. We have also cleared this date and time with Kevin Halbach of CD Smith Construction, the project manager in charge of the current construction on the Riverside III parking ramp.
5. A dumpster to be on the premises for waste disposal.
6. Use of the Pedestrian Walkway east of the Pump House Regional Arts Center for beverage vendors.
7. We request that the electrical outlets on the light poles be turned on throughout the described area for decorative lights.

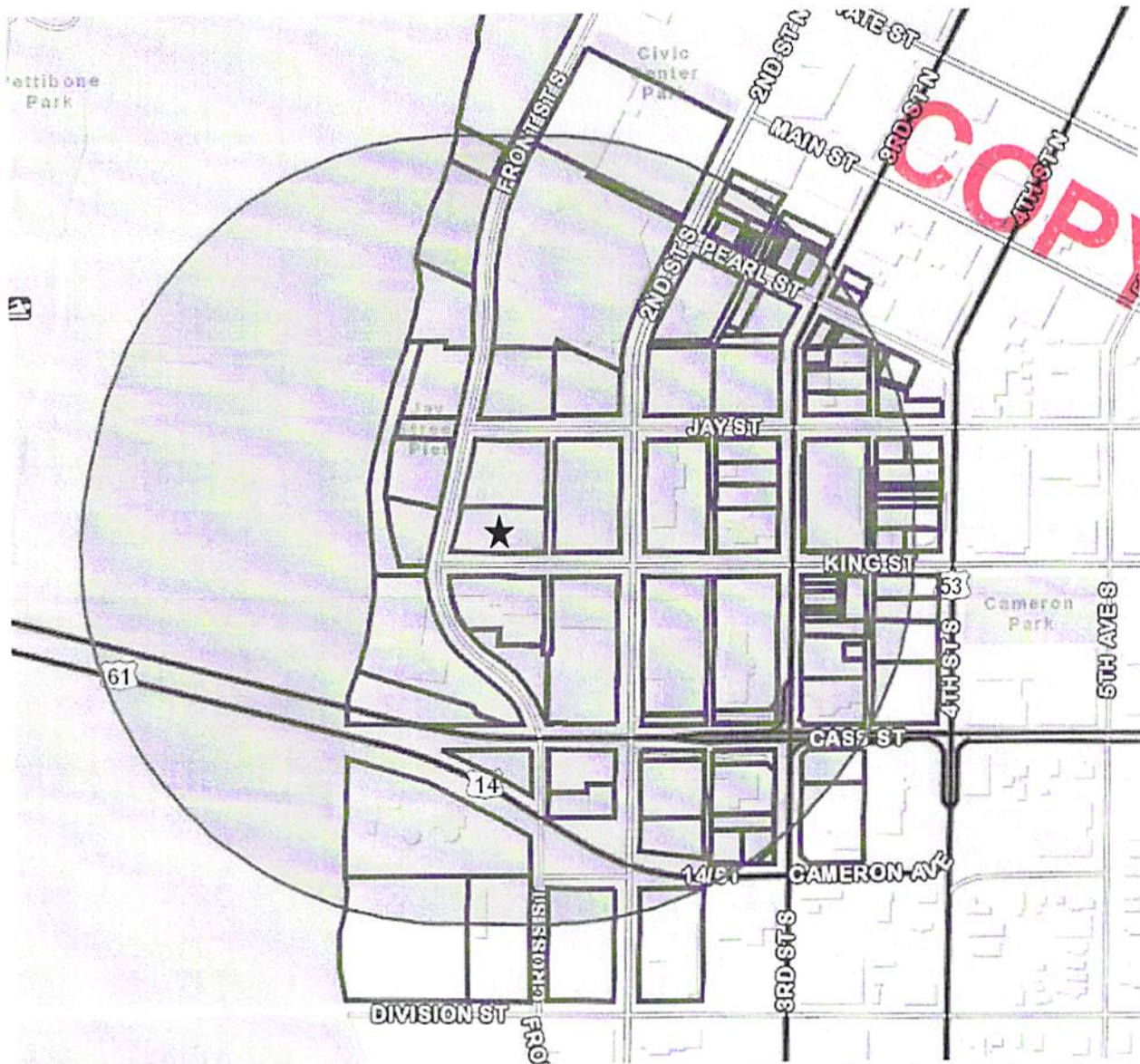
