AN ORDINANCE to amend Section 15.02(B) of the Code of Ordinance of the City of La Crosse by transferring certain property from the Heavy Industrial District to the Traditional Neighborhood District to allow for a multi-family residential building at 2219 South Ave.  
THE COMMON COUNCIL of the City of La Crosse do ordain as follows:  
SECTION I: Subsection (B) of Section 15.02 of the Code of Ordinances of the City of La Crosse is hereby amended by transferring certain property from the Commercial District to the Special Multiple District on the Master Zoning Map, to-wit:
