SECTION I: Section 103-8 is hereby created to read as follows:
103-8 Residential Rental Dwelling Unit Registration.
(a) All properties containing at least one residential rental dwelling unit must be registered with the City of La Crosse by submitting a completed registration form, made available by the La Crosse Fire Department's Division of Community Risk Management. (1) Name of the owner of each residential rental dwelling unit.

(b) Changes to the required registration information such as ownership or changes to the authorized contact person for each rental property must be submitted to the City within 30 days of change.

(c) Residential rental dwelling unit owners must submit a registration STATE OF WISCONSIN } ss. La Crosse County owners must submit a registration fee per property established by resolution simultaneous to filing registration.
(d) Residential rental dwelling unit being duly sworn, doth depose and say that he (she) is an authorized (d) Residential rental dwelling unit means any independently rented living space whose term of lease is 30 days or greater. It does not include facilities that are inspected, owned, licensed or certified by the State of Wisconsin including rest homes, convalescent homes, nurs-ing homes, hospitals, assisted living centers, community based residenrepresentative of Lee Enterprises, publishers of LA CROSS TRIBUNE centers, community based residen-tial facilities, university-owned stua newspaper, at La Crosse, the seat of government of said State, and that an advertisement of which the annexed is a true
