The residents of Sunset Ln are writing this letter in collaboration to express our opposition of the proposed petition to make the west side of Sunset Ln no parking. While many of us were supportive and signed the petition of our neighbor down the road to make the east side of Sunset Ln no parking, we as a whole agree that no parking at all on Sunset Ln from the 2000s all the way to the 2200 addresses is unnecessary and unreasonable.

The petition to change the east side to no parking stemmed from the petitioner's dissatisfaction of renters parking on the edge of his front yard. While we were willing to support him in making changes to the east side of the road, we are not willing to give up all street parking in it's entirety for the majority of Sunset Ln. We believe this is a very unreasonable request that does not offer any substantial benefits to Sunset Ln.

The petitioner claimed it was hard for him to drive down Sunset Ln in his large truck with vehicles parked on both sides of the road. That issue has been resolved by making the east side no parking. The petitioner was unsatisfied with renters parking in front of his house. That issue has also been resolved by no east side parking. To further say that the residents of Sunset Ln should forfeit all street parking on both sides of the road is unwarranted, unreasonable, and unnecessary. We need to keep the west side of street parking available for ourselves, our families, and our guests.
