Hi Council member,

Thank you for reaching out for my perspective on the matter. This topic has been highly debated throughout the country with many jurisdictions exploring this approach.

I certainly understand some of the community's frustrations about the number of unsheltered individuals and how some of them treat the property they're on. If we accomplish what we set out to in the five-year plan to address homelessness, that stress will be greatly reduced.

In the meantime, the research has shown that writing tickets, arresting people, or disbarring them from public spaces is an ineffective method to address the issue. People still have the same need for a place to exist and they turn to even more dangerous corners of our community such as by rivers, under bridges, and in other isolated corners. This makes it more difficult for service providers to connect with them and help them get services and housing when it becomes available. It also makes people susceptible to overdose deaths and other medical conditions—we've already had over 20 overdose deaths in La Crosse this year (an astronomically high number), with a lot of the deaths being people who were homeless or previously homeless.

The communities that have had success addressing unsheltered homelessness have created acceptable, safe, and legal places people can be (I.e housing) instead of creating places people can't be.

In summary, I don't see how this ordinance would be helpful to the larger quest at hand which is to ultimately help folks get out of the parks and streets altogether and into housing or shelter.

Please feel free to share my input with other city council members, as you are the first to ask my opinion.
