Dear La Crosse City Council,

We respectfully request your review of the below petition regarding the property at 2402 La Crosse Street.

REQUEST

We, interested neighbors of the property at 2402 La Crosse Street, **recommend that you deny any upcoming requests to extend the deadline for the vacation of Campbell Road** as an expansion space for development of 2402 La Crosse Street (formerly Heeter's Garage).

BACKGROUND

On July 13, 2023, a conditional request was approved for the new owners of 2402 La Crosse Street to expand development to the median on the section of Campbell Road adjacent to the property (see Resolution 23-0462).

Prior to developers approaching the city council to ask for the street vacation, the proposed plan for the property was a small scale building with retail space on the bottom ("perhaps a smoothie shop") and a 2 storey building with 1-2 loft style apartments. This was the same preliminary plan presented to the neighborhood when the developers attended the GENA and Bluffside meetings in February 2023. The Common Council meeting on July 13, 2023, and the preliminary committee meetings leading up to it between 6/26/23 - 7/6/23, made recommendations to vacate Campbell Road without any concrete plan having been submitted by the developers. The plan now being pursued for the property is significantly different from the original one proposed to the council and at neighborhood meetings. Though the official plan has not yet been submitted, developers have stated via Jenasea Hameister their intentions to include at least 12 apartments in a 3-storey building, including the expansion into Campbell Road.

We residents have had no proactive notification of, involvement in, or council representation in these changes in plans or in the proposed expansion into Campbell Road.

STATEMENT OF INTENT

We are excited for the prospect of new development at the property, and of the developers having a profitable outcome. However, we have significant concerns about the impact that expanding into Campbell Road may have on the neighborhood and on the city. We are working with GENA and continuing to attempt to arrange a discussion with the developers to ensure we understand their plans, and have an opportunity to work constructively and respectfully with them to arrive at a mutually beneficial outcome for all.

We recommend that you deny any requests for extensions to the 150 day deadline to meet the conditional requirements put forth by Resolution 23-0462 regarding the partial vacation of Campbell Road. As stated in the attached petitions, the residents in the surrounding area of the proposed development did not have an opportunity to enter our concerns into public record prior to the approval of the original resolution on July 13,2023 and are opposed to the vacation of Campbell Rd. Should the conditional items not be completed by the original December 10,2023 deadline, the partial vacation agreement with the city of LaCrosse should be considered null and void.

Petition to Deny Campbell Road Vacation

We, the undersigned, are opposed to granting any time extension to the 150 day deadline put forth in Resolution 23-0462 regarding the conditional approval of the partial vacation of Campbell Road by the City of LaCrosse. Should the conditional items not be completed by the original December 10, 2023 deadline, the partial vacation agreement with the City of LaCrosse should be considered null and void. The community did not have an opportunity to enter our concerns into public record prior to the passage of the original resolution on July 13,2023 and we believe it's in the best interest of the neighborhood and the City of LaCrosse not to vacate this portion of Campbell Road.
