LACROSSE MEMORIAL SWIMMING POOL EVALUATION September 2015

SCOPE:

LaCrosse Memorial Swimming Pool was put in service circa late 1930's. The pool has approximately 330,00 gallons of water and is in service from Memorial Day to Labor Day with an averages of about 25-30 swimmers per day.

The directive of this study is to determine what investment is needed to bring the current facility up to code, increase usage by the neighborhood as well as reduce the labor and operational cost.

The following table shows the current status of the pool compared with the State of Wisconsin's swimming pool codes.

OBSERVATIONS:

- 1. The current gutter system is a scum gutter meaning that the water that flows into the gutter flows to the sanitary system. The pool loses at least 4 inches of water per day due to these configuration resulting in the addition of 26,000 gallons of water per day or 2,470,000 for a 90 day pool season.
- 2. Current pool codes do not allow gutter water to go to waste. Gutter water must be recovered in a surge tank then treated and returned to the pool. The current gutters system will have to be replaced and a surge tank installed sized to hold 1 gallon of water per square foot of pool surface area
- 3. The current turn over time of the pool's recirculation system is 8 hours. The swimming pool code requires a minimum of turn over rate of 6 hours which will increase the flow rate from 688 gpm to 916 gpm. These increase in flow rate will have the following results:
 - a. the filter system will have to be replaced because the current rapid rate filters, filter at 1 gallon of water per square foot of filter area and with a new flow rate of 916 gpm these filters are too small
 - b. with an increased flow rate the current recirculation piping is under sized and all piping will have to be replaced with properly sized piping.

- c. In addition much of the piping under the deck is original and its integrity must be questioned
- d. The current pump is too small to pump the quantity of water required by code thus the pump will have to be replaced
- e. Due to increase flow rate the number of inlets in the pool must be increased
- 4. The Pool is currently out of compliance with Federal Department of Justice ADA laws
- 5. The bath house is not in current compliance with Wisconsin Code SPS 390.19 in regards to the number of required toilets, showers, lavatories and diaper changing stations. In addition certain emergency situations may prevent emergency personnel from treating a victim due to physical restraints of the building
- 6. Without a pool heater the water temperature prohibits certain activities from taking place, however with the addition of about 26,000 gallons of water per day the heating cost would be prohibitive.
- 7. This pool provides no programing , shade, green spaces, or interactive play features to draw swimmers .

ACTION PLAN:

- 1. To bring Memorial Pool into code but not including improvements to increase attendance the following should be enacted:
 - a. Replace gutter system. The cost is \$1,250.00 per foot or \$587,500.00. This system will also correct the need to increase the number of inlets.
 - b. Add surge tank to handle in pool surge should be budgeted at \$65,000
 - c. Replace filter system and pumps as well as chemical treatment system: \$110,000.00
 - d. Replace all piping from pool to surge tank budgets at \$1,200 per foot or about \$120,000
 - e. Add piping from surge tank to filter system budget \$50,000.00
 - f. Bring Bath house into code. This is not an area we have worked in so we do not have budget numbers. However the last pool we worked on with a similar project on a smaller scale the bathhouse renovation bid was \$650,000.00

The cost without the bath house renovation estimate is \$932,000.00
