

ORDINANCE No.: 5007

AN ORDINANCE to annex a parcel of land from the Town of Campbell to the City of La Crosse (1504 Nakomis Avenue - Allen).

THE COMMON COUNCIL of the City of La Crosse do ordain as follows: SECTION I: Proper petition having been presented to the Common Council of the City of La Crosse praying for annexation of the following territory, to-wit: Annexation Description for 1504 Nakomis Avenue Lot 5 of Hi-awatha Islands Addition and part of Government Lot 4 in Section 19, Township 16 North, Range 7 West, La Crosse County, Wisconsin more particularly described as follows: Commencing at the Southeast corner of said Section 19; thence N 2°21' E, 219.22'; thence N 86°42' W, 244'; thence N 83°34' W, 977.5' to the East right of way line of Nakomis Avenue; thence Northerly along said East right of way line N 0°14' E, 994.0'; thence continuing along said East right of way line N 0°14' W, 400' to the Southwest corner of Lot 5 of Hiawatha Islands Addition and the point of beginning of this parcel description; thence N 80°18' E, 150' more or less along the South line of Lot 5 to the West waters edge of the Black River; thence North along said West waters edge of the Black River 100' more or less to the North line of Lot 5; thence S 80°18' W, 150' more or less to the Northwest corner of Lot 5 said point being also on the East right of way line of Nakomis Avenue; thence continuing S 80°48' W, 30' more or less to the Northwest corner of Lot 5 said point being also on the East right of way line of Nakomis Avenue; thence continuing S 80°48' W, 30' more or less to the Centerline of the 60' wide right of way of Nakomis Avenue; thence Northerly along said centerline, 45' more or less to its intersection with the Easterly prolonged South line of Lot 35 of the Second Addition to Hiawatha Islands Addition; thence Westerly along said prolonged line, 30' more or less to the Southeast corner of said Lot 5 and the point of beginning.

The County Board of Supervisors for La Crosse County is further requested to have the annexed area included in the same district for the County Supervisor's seat as for the City Council Member.

SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.

SECTION IV: This Ordinance shall take effect upon its enactment.
