AN ORDINANCE to amend Section 8-21 of the Code of Ordinances of the City of La Crosse regarding the Aviation Board membership.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

SECTION I: Section 8-21 is hereby amended to read as follows: Sec. 8-21. - Creation and member-

ship. There shall be an Aviation Board

consisting of seven voting members and up to three non-voting ex officio members. Voting Bboard members shall be appointed by the mayor for a term of three years. The Mayor's voting board member appointments shall be subject to the confirmation of the Council. Ex-officio members shall be appointed and remove by the Mayor and shall serve a term of shall be appointed and remove by the Mayor and shall serve a term of two years. One voting member shall be a member of the Common Council and one voting member shall be a member of the County Board of Supervisors. A minimum of four voting members shall be residents of the City. Ex-officio members need not be residents of the City. The Council Member shall be the Chair. The Vice-Chair shall be elected by the body every twenty-four months on the first regular meeting of the year.

SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of the article shall not be affected.

SECTION III: This ordinance shall take effect upon passage and publications.
