- 1.) River Bank for the \$10,000,000 level of investment at the rate of .0021 per month in excess of the monthly rate established by the State of Wisconsin Local Government Investment Pool (LGIP) including collateralization, and
- 2.) Coulee Bank for the \$10,000,000 level of investment at the rate of .0031 per month in excess of the monthly rate established by the State of Wisconsin Local Government Investment Pool (LGIP) including collateralization, and
- State Bank Financial for the \$1,000,000 level of investment at the rate of .0011 per month in excess of the monthly rate established by the State of Wisconsin Local Government Investment Pool (LGIP) including collateralization,

all in accordance with the attached report of bids and recommendations of the Director of Finance/Treasurer, and

BE IT FURTHER RESOLVED that the Mayor and City Clerk are authorized to sign said Investment Services agreements on behalf of the City, and

BE IT FURTHER RESOLVED that the Director of Finance/Treasurer is hereby authorized to take any and all steps necessary to effectuate this resolution.
