AN AMENDED ORDINANCE to amend Subsection 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Single Family District to the Traditional Neighborhood District - Specific allowing development of single family homes, shelter and green space on vacant lots at 2226 Green Bay Street.

SECTION I: Subsection 115-110 of the Code of Ordinances of the City of La Crosse is hereby amended by transferring certain property from the Single Family District to Traditional Neighborhood District - Specific on the Master Zoning Map. to-wit:

NAVY RESERVE ADDITION, LOTS 1 THROUGH 8 AND OUTLOTS 2 AND 3 CITY OF LA CROSSE, LA CROSSE COUNTY, WISCONSIN.

SECTION II: Said zoning is conditioned upon the preliminary plat being approved by the Common Council.

SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.

SECTION IV: This ordinance shall take effect and be in force from and after its passage and publication.
