

OBJECTION TO ISSUANCE OF CONDITIONAL USE PERMIT

I hereby object to the issuance of a Conditional Use Permit at the following location
3120 Farnam Street La Crosse, WI 54601

I object for the following reason(s):
A transitional housing facility for 10 individuals would dramatically impact our neighborhood. The primary reasons I am apposed
are: Safety of children living adjacent to the home, drop in property values of up to 17% for neighboring homes, lack of sufficient
parking for residents -visitors & neighbors, tax exempt status of the VA home, and the home being directly in the middle of
single family homes with very close proximity to neighbors. In addition the VA said this is a new concept and the transitional
housing facility they currently have is on the Tomah campus and they do not have data on how this concept will work off campus.
I agree with the all the other concerns expressed by home owners in our neighborhood regarding the conditional use permit.

To Whom it may concern:

We are writing this letter in opposition to the conditional use permit for 3120 Farnam Street La Crosse, WI. There is no doubt from the various meetings held and letters submitted that our neighborhood supports Veterans, but the **location** of the transitional housing facility is of grave concern. We agree with all the concerns shared both in meetings and documentation with our primary concern being safety of the children in our neighborhood. Three of the primary goals of Therapy/Transitional Residence Program housing is to minimize reliance on institutional care, learn anger and stress management and other problem-solving skills, remain sober and improve mental health status in a supportive residential setting. These items alone could lead to unforeseen emergencies and safety risks to our neighborhood.

There is one other very important concern we have for the proposed conditional use permit. Studies show that home values located near a group living facility depreciate 17%. This means a home valued at \$170,000 would drop in value \$28,900 due to no fault of the home owner. The significant drop in property value (but no drop-in property taxes) is wrong and will put undue financial stress on the home owners. To move forward with the conditional use permit which negatively impacts resident of our city and this would be extremely unfortunate.

At the meeting held at the VA facility in La Crosse on September 26, 2018 the VA administrator indicated there is one transitional housing facility near La Crosse and it is on the VA campus in Tomah. This setting is quite different from a neighborhood setting, and they have resources close by to assist with emergencies that arise. The VA shared there is one facility in Madison and possibly one in Milwaukee, but the VA could not speak to specific details of these homes including location, emergency calls, police calls etc. I think it is important to look at these other facilities, locations, emergency call statistic etc. to help evaluate what setting has been most effective for this new housing concept and is it a good fit for an R-1 residential zoned neighborhood and for the Veterans being served.

Thank you for your time and consideration regarding these concerns. We encourage more conversation and collaboration to help find a solution to find a location better suited for a transitional living facility that will meet the needs of the VA residents and our neighborhood.
