Due to the depth of the excavation to remove and replace the unsuitable soils we will undermine the duct bank. Undermining the duct bank will cause it to crack and compromise the conductor inside. The duct bank is a \$1M piece of infrastructure for Xcel.

Attached is the cost to install earth retention to support the duct bank while the contractor removes and replaces the unsuitable soils.


