AN AMENDED ORDINANCE to amend Section 2-422(c)(6) and Section 2-422(d), (e) and (f) of the Code of Ordinances of the City of La Crosse regarding residency requirements on boards, commissions and committees.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows: SECTION I: Section 2-422(c)(6) is hereby amended to read as follows: 6) Gusteinable Le Greece Commission in accordance with division 10 Bicycle and Pedastrian Advisory Committee in accordance with Resolution No. 19-1807.

SECTION II: Section 2-422(d), (e) and (f) are hereby amended to read as follows: SECTION II: Section 2-422(d), (e) and (f) are hereby amended to read as follows:

(d) Netwithstanding the provisions contained herein, and in accordance with Resolution 2098-99-917, up to four members of the City of La Gresse Arts Beard may be nonresidents, in the event the member from the La Gresse County Beard of Gupervisore lives outside the City-limits, such member shall constitute are of the four nearesident members:

(ed) Notwithstanding the provisions contained herein, the Animal Control Governing Board may consist of up to four nonresident members in compliance with the Animal Control Agreement.

(fe) Subsection (a) and (b) of this section shall not apply to City employees or other technical staff where their expertise is essential to the board, commission or committee.

(i) Notwithstanding subsection (a), the Mayor may reappoint, subject to Council confirmation, the non-resident for the residue of the non-resident is term after a vacancy is created by epilication of subsection (a). This subsection shall not apply to governing bodies where residency is required by authority other than subsection (a).

SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.
