ORDINANCE NO.: \$185

AN AMENDED ORDINANCE to amend Section 2-422(c)(6) and Section 2-422(d), (e) and (f) of the Code of Ordinances of the City of La Crosse regarding residency requirements on boards, commissions and committees.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows:
SECTION I: Section 2-422(c)(6) is hereby amended to read as follows:
(6) Sustainable La Grosse Gammission in accordance with Avision 10 Sicrole and Padastrian Advisory Committee in accordance with Resolution No. 19-1907
SECTION II: Section 2-422(d), (e) and (f) are hareby amended to read as follows:
(d) Notwithstanding the provisions contained herein, and in accordance with Resolution 2000-09-017, up to four members of the Gity of La Grosse Arts Board may be nonresidents, in the event the member from the La Grosse County Poard of Supervisors lives entained herein, the Antimal Contrat Governing Board may consist of up to four nonresident members in compliance with the Animal Control Agreement.
(d) Natwithstanding the provisions contained herein, the Animal Control Governing Board may consist of up to four nonresident members in compliance with the Animal Control Agreement.
(f) Subsection (a) and (b) of this section shall not apply to City employose or other technical staff where their oxpertice is essential to the board, commission or committee.
