Inpro's Estimators Qualifications - Please read:

- There is a discrepancy with PVC corner guard retainer type in this project. Spec. section 102601 identifies aluminum retainers; however, the part number listed is the #160BN, which comes with a vinyl Blunose retainer. This bid furnishes IPC's standard #160 series corner guard with an aluminum retainer. Contractor to verify prior to placing order.

- CG-1 stainless steel corner guard mounting type is not identified. This bid furnishes IPC's cement-on stainless steel corner guards. Contractor to verify prior to placing order.

- WP-1 and WP-2 rigid sheet typical installation height is not specified. This bid furnishes 4'x8' sheets to be mounted horizontally, to a maximum height of 48". Contractor to verify prior to placing order.

- Exclude CR-1 wall guard runs less than 6" in length.

- Exclude any patch to match existing finishes. Existing finishes are unknown.

- Elevations 9 and 10 on sheet 3A6-11 appear to identify non-standard trim and custom butt-joint angles (77° and 103°) for WP-1 rigid sheet. Any custom cutting to obtain these joints will need to be completed by the contractor in the field.

- Exclude WG-1 stainless steel wall guard runs at curved wall sections. This product cannot be bent. Also, exclude WG-1 stainless steel wall guard at runs less than 18", as these runs are too short for the product to be installed.

- Installation requirements were not provided for handrail/wall guard at inside and outside corners on this project. This bid includes IPC's standard returns and end caps terminating prior to all corner conditions.

- Exclude inside corner trim pieces at angles other than 90 degrees for sheet material. This bid includes matching #585 caulk for these conditions.

- WG-1 is noted on "all walls in service hall" per the returned shop drawings stamped 6/3/20; however, exact locations were not drawn out. This bid furnishes a double rail of WG-1 on all walls in the service hall, but the contractor will need to verify exact locations with shop drawings prior to placing order.

- WP-1/WP-2 wall protection system, as required in Corridor N216 by elevation 8/3A6-11, properties are unclear. This bid furnishes 4'x8' sheets of IPC's #405 series Palladium rigid sheet to be field-cut into custom shapes by the installer. Panels are to be glued directly to wall surface and finished with IPC's provided #585 color-matched caulk at all edges. Contractor to verify properties prior to placing order.

- Standard Payment Terms: 2% 10 Days/Net 30 - No Retention. Terms subject to change at Inpro's discretion.

- State, County and City tax, if applicable, will be added to the invoice at time of billing.

- Quoted price includes one (1) shipment. Additional shipments at customer's request will incur additional shipping charges.

- This bid specifically excludes all labor and cost thereof to install products in this proposal.
