This letter is in response to the Letter we received on June 1, 2021. The letter informs us that Fish's Tavern is applying for a beer garden license.

Please consider the following before granting the permission to build, move or add on to the beer garden area. Fish's tavern is requesting to move the beer garden to the south end of their property, which is toward our home.

We are both middle aged and married. We want to live along side and be good neighbors, but we think that the new planned extension is way too much. Again, it will be less than 9 feet from our personal space and 3'4" from our legal fence.

Over the past 26 years We have heard and never complained to the vulgar, intoxicated language and rude behavior, the cigarette smoking and cigarette butts being thrown over the fence into our yard. If the application for the beer garden is granted it would be 13' closer to our home making things unbearable. We have our grandchildren stay with us often and feel they too would greatly be impacted by this change. Please consider if it were your home, very few would tolerate what they are proposing.

In addition, we received on June 1<sup>st</sup>, 2021, there isn't anything on the front side of the letter that indicates Fish's wanting to move the fence. It wasn't until I called the city and it was brought to my attention that it was on the back of the letter. Attached is the copy of the letter I received so you can use this as a reference. It would have been appreciated if Fish's tavern were more transparent with their intentions. Not a very informing letter about all the things Fish's is requesting. In addition, we received this letter at 4pm on June 1<sup>st</sup>. As you know the meeting to discuss our concerns was at 6:00pm. It would have been considerate to give all concerned homeowners ample notice to share their concerns.

We have accepted (despite how we truly feel) the current location of the beer garden. However, we are <u>not</u> in favor if the move as it would then be less than 9 feet from out bedroom wall and living room wall. We currently have a 6 foot fence up already, and they <u>had</u> a 6 foot fence up but tore it down to try to move it before they had a permit to move it. Even when both fences were up, the noise was very disturbing and at times inappropriate. They now play bean bag toss (corn hole) which is very load as well. They also have an outdoor speaker which is often too load.

In an effort to work together, we are in agreeance if the beer garden stays at the previous dimensions and location or if the relocated it to the east side of their building. As long as it does not come South, towards our home. Please consider our concerns and not grant the permit being moved to the South.
