The proposed museum planning studies are the next step in achieving the museum that the Coulee Region deserves. The La Crosse County Historical Society holds thousands of artifacts preserved for the public good that tell the stories of life in the Coulee Region. A regional history museum in La Crosse would clearly benefit tourism and the large cruise boats that visit La Crosse, but it would also benefit our entire community.

Reading about history versus seeing the artifacts in person is a drastically different learning experience. I will never forget the understanding and joy that I see wash over visitors when they engage with logging artifacts at the Heritage Center and finally understand a piece of our shared history that they thought they understood. The logging industry is just one small aspect of our history.
