

14th Street Vacation

Legal Description

Part of the Northwest Quarter of the Southeast Quarter of Section 32, Township 16 North, Range 7 West, City of La Crosse, La Crosse County, Wisconsin being more particularly described as follows:

Beginning at the Northwest corner of Lot 9, Block 3 of the Mons Anderson and B. E. Edwards Addition said point being on the East right of way line of 14th Street; thence South along said East right of way line, 305' more or less to the Southwest corner of Lot 10 of said Block 3; thence West, 66' more or less to the Southeast corner of Lot 8, Block 4 of said Addition, said point being located on the West right of way line of 14th Street; thence North, 305.5' more or less along said West right of line to the Northeast corner of Lot 1 of said Block 4; thence East, 66' more or less to the point of beginning.
