Jason Gilman gave an overview. Lee asked about code enforcement. Kabat stated they can invite Building Safety and Fire Prevention to come report on code enforcement and they could cover any policy issues within priority number two. Gilman stated there is a catch all statment to be used for requesting updates on things such as code enforcement. Kabat stated as a homework assignment the group should look at the items that they can work on and notify staff and the committee. A motion by Sleznikow, seconded by Lee to adopt as the proposed 2020 workplan. The motion carried by voice vote.

Jason Gilman gave a presentation on the 2020 Comprehensive Plan. Gilman requested feedback on data such as what kinds of data staff should be looking at, and suggestions on who staff should be interviewing. Kabat asked if staff has a document on the type of data being collect. Gilman stated he has two documents based on past and current data being collected and will share the documents with the commission members.
