Agenda Items:

Interior review on LCC wall treatments, ceiling treatments, concession stands, floor coverings, chair rails, uplighting and more presented by Jennifer Stangl Senior Interior Designer for ISG.

Jennifer Stangl of ISG updated the board on the latest interior treatments being considered. The first part of the presentation dealt with staying within the original inspirations of "Evolve/Explore/Enrich".

The following areas and a video presentation of possible treatments were shown:

- 1) Floors of the North Hall and the Arena
- 2) Doors
- 3) New entrance look...open ceiling, walls and flooring
- 4) Chair rails and corner wall protection
- 5) Historical Features
- 6) Concourse....ceilings, walls, wall bases, floor, counter tops
- 7) Concession stands
- 8) Ballroom carpet with a wave effect flowing from the prefunction area into the ballroom
- 9) Uplighting inside and out
- 10) Meeting rooms

Board accepted the report and look forward to future updates.

Rate Card Discussion

The current proposed rate card for 2022 and beyond was presented. The board discussed the card. They were made aware a number of factors go into a rate card and negotiations with clients. They requested that the current rate card be emailed out to them and it will be further discussed at upcoming LCC Board meetings.

Branding Update from Vendi Advertising

Kate Weis and Kathy Van Kirk presented the latest findings on their Branding effort. They have gathered information from research with end users, board, general public and other stake holders. President Smith discussed the conversation with the Mayor about a marketing position at the Center. The desire is to ask the Mayor to switch the new sales position scheduled for 2020 to a marketing position. Then add back in the sales position for 2021. To be brought back to the full board.

Director's Report***Signage in/on Parking Ramp Discussion**

Director Fahey reported that there have been conversations with City Planner, Traffic Engineer and the Chief City Inspector in reference to an Electronic Messaging Unit on the LCC Parking Ramp on 3rd Street promoting events at the Center. The City Inspector ruled that a sign of this nature is considered an off premise sign. With that designation the sign could only promote the building that is was on which is the parking ramp. As a result we could not promote events in the Center.

The second question that needs to be answered is what is allowed on this street from the State of Wisconsin. 3rd Street is Hiway 53 and the Great River Road. They directed Fahey to get that answer from the State.

If it is possible from the State's view point then an appeal would have to go to the Board of Zoning Appeals on the local level.

To be brought back to the La Crosse Center Board.

Fahey also reported that this coming weekend was the State of Wisconsin Pom and Dance Competition bringing in thousands of people to the downtown.
